ORDER ESTABLISHING AMENDED PROCEDURAL SCHEDULE

This matter came before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") during a telephone status conference held on June 3, 2019 with Tennessee-American Water Company ("TAWC") and the Consumer Advocate Unit in the Financial Division of the Office of the Attorney General ("Consumer Advocate"), the parties in this matter. During the Status Conference the parties discussed with the Hearing Officer the need to amend the procedural schedule to allow the Consumer Advocate to file supplemental testimony in Docket No. 18-00120 based on TAWC's revised calculations ordered by the Commission in Docket No. 18-0022 and to allow for additional time for the parties to discuss Docket Nos. 18-00120 and 18-00039. The Hearing Officer expressed concern that there was a lengthy hearing scheduled in another matter for August but stated she would tentatively schedule this matter for a target hearing date of August. However, if a full hearing in the other matter went forward in August, this matter may need to be moved to September. With that caveat, the Hearing Officer found the parties' request was well taken and hereby amends the Procedural Schedule previously issued in this matter and establishes the Amended Procedural Schedule set forth in Exhibit A attached to this Order.
