On behalf of Mitel Cloud Services, Inc. (“MCSI”), this letter advises the Tennessee Regulatory Authority that MCSI elects to operate under market regulation pursuant to T.C.A. MCSI was approved by the Commission to provide resold local exchange service on January 3, 2006 (Docket No. 05-00272). MCSI wishes to cancel its tariff.

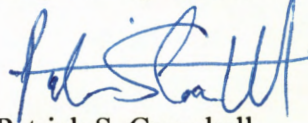
