APPLICATION OF BTC COMMUNICATIONS, LLC FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY TO PROVIDE INTRASTATE TELECOMMUNICATIONS SERVICES STATEWIDE

BTC Communications, LLC ("BTC" or "Applicant"), by and through its undersigned counsel, and pursuant to Tenn. Code Ann. §§ 65-4-201 through 65-4-204 and Chapter 1220-4-8 of the Rules and Regulations of the Tennessee Public Utility Commission ("TPUC" or "Commission"), as applicable, hereby submits this *Application of BTC Communications, LLC for a Certificate of Public Convenience and Necessity to Provide Intrastate Telecommunications Services Statewide* (the "Application").

BTC was formed in 2016 and has its principal office in Pikeville, Tennessee. Until 2018, it was wholly owned by Bledsoe Telephone Cooperative Corporation ("Bledsoe"), a telephone cooperative incorporated in Tennessee in 1953. In 2018, Bledsoe transferred and assigned its ownership interest in BTC to its wholly owned subsidiary Tennessee Telecommunications Company ("TTC"), a Tennessee corporation formed in 2017. BTC is now wholly owned by TTC.

As provided further below, BTC seeks to provide a full array of telecommunications services on a statewide basis, as business conditions warrant, including, without limitation, in Rhea County, Tennessee. As set forth herein, BTC has the managerial, financial, and technical fitness to provide the applied-for services in the State of Tennessee. As demonstrated below, the granting of this *Application* will provide significant benefits to Tennessee consumers and thereby serve the public interest. In order to serve the public interest in a timely manner, BTC requests expedited consideration and approval of this *Application*.

In support of the Application, BTC submits the following.

4. <u>Corporate Information</u>: As set forth and established by the Applicant, BTC was formed as a limited liability company in 2016. BTC's Articles of Organization are attached hereto in <u>Exhibit C</u>. The biographies of the principal corporate officers, members of the Board of Directors, and staff of BTC are attached hereto in <u>Exhibit A</u>. BTC is a wholly-owned subsidiary of TTC. TTC is a wholly-owned subsidiary of Bledsoe.

II. **QUALIFICATIONS**

Since 1953, Bledsoe, the parent entity of TTC, which wholly owns BTC, has gained valuable experience as a telecommunications provider. It provides landline, IPTV television, long distance, ADSL, fiber optic internet broadband, and surveillance services. With this

experience, and as demonstrated below and in the Pre-Filed Testimony of Charles H. Boring (attached as **Exhibit E**), BTC possesses the requisite managerial, technical, and financial ability to provide local telecommunications service throughout the State of Tennessee. BTC is the only entity owned by TTC, and TTC is similarly the only entity owned by Bledsoe. As such, Bledsoe's 65 years' of experience will manifest itself through BTC's services to Tennessee customers.

1. <u>Managerial</u>: Bledsoe has been providing telephone services in Tennessee since 1953, primarily to Tennesseans in the five (5) Tennessee counties serviced, namely Bledsoe, Sequatchie, Van Buren, Cumberland, and Hamilton Counties. As a result of BTC's owner's history as a telecommunications provider since 1953, BTC will operate under a seasoned, well-established telecommunications provider. Hence, BTC has the foundation necessary to provide the proposed telecommunications services and to serve Tennessee's telecommunications consumers throughout the state.

As it is owned by a long-serving telecommunications provider, BTC is managerially qualified to provide telecommunications services statewide. BTC is led by the same group of individuals leading Bledsoe, specifically John Lee Downey, President, and he is supported by highly qualified and competent directors, officers, and staff, including the General Manager, Charles H. Boring. Attached hereto as **Exhibit A** is a list of the names of the Applicant's principal company officers and a description of each officer's background and experience. As shown in **Exhibit A**, these officers of the company have substantial managerial experience in the areas of utility operations, utility customer service and utility marketing.

2. <u>Financial Qualifications</u>: BTC is financially qualified to provide a full array of telecommunications services statewide, as its owner has been successfully providing such

services for more than fifty (50) years. While neither BTC nor TTC has any financial statements to provide at this time, because they have not yet provided any services, BTC submits as **CONFIDENTIAL Exhibit B** the 2016 and 2017 Audited Financial Statements of Bledsoe, which demonstrate that BTC's owner entity is financially qualified for its subsidiary to provide telecommunications services statewide. **CONFIDENTIAL Exhibit B** is being submitted **UNDER SEAL** as **CONFIDENTIAL AND PROPRIETARY**.

Technical Qualifications: Based in part on its parental entity's experience since 1953 as a telecommunications services provider, coupled with BTC's managerial experience, BTC possesses the necessary technical qualifications to provide a full array of telecommunications services throughout Tennessee. As noted earlier herein, BTC's owner entities have successfully serviced their telecommunications customers since 1953. Information concerning the technical expertise of BTC's senior management team, which are the same individuals who make up the management team of Bledsoe, is included in **Exhibit A**. This experience provides BTC with the foundation necessary to provide the proposed telecommunications services. BTC will file and maintain tariffs in the manner prescribed by the TPUC and will meet minimum basic local standards, including quality of service and billing standards required of all LEC's regulated by the TPUC. BTC possesses the requisite level of telecommunications expertise and is technically qualified to offer the proposed services.

III. PROPOSED SERVICES

1. In addition to its current offerings, BTC intends to offer a full range of telecommunications services via VoIP and other platforms, including, but not limited to, dedicated and switched access services, private line services, local dial tone, 911 and E911 emergency services, enhanced services and all other Commission-required Rule 1220-4-8-

.04(3)(b) services. To the extent appropriate and necessary, BTC may supplement its services by leasing the facilities of third party carriers and/or by reselling the services.

- 2. BTC desires to provide telecommunications services throughout the State of Tennessee in order to offer consumers increased carrier choices, competitive pricing, increased reliability, responsiveness, and innovation.
- 3. BTC understands the importance of effective customer service for local service customers. Upon obtaining the requested expanded certification, BTC will continue the operation of its toll free customer service number, which will continue to be printed on the customers' monthly billing statements. Additionally, customers may write to BTC at P.O. Box 607, Pikeville, Tennessee 37367 or call 1-888-437-7340. In the past year, Bledsoe has had two formal customer service complaints filed against it with the FCC, one regarding internet speed and another regarding the non-use of a required telephone land line. Bledsoe responded appropriately and timely to the FCC with respect to these complaints. Since responding to the FCC regarding these two complaints, Bledsoe has not been contacted by either the customer or the FCC regarding the same. Hence, Bledsoe considers the complaints resolved. As of the date of this filing, the FCC's Consumer Complaint Center indicates there are no complaints against Bledsoe, BTC, or TTC.
- 4. To the extent that any rural incumbent LEC possesses an exemption or suspension under Section 251(f) of the Federal Communications Act (the "Act") that applies to BTC, BTC does not seek interconnection under Section 251(c) at this time, nor does BTC seek at this time to challenge any such exemption from any of the other obligations specified in Section 251(c) of the Act.

IV. REGULATORY MATTERS

- 1. The Applicant is familiar with and will adhere to all applicable Commission policies, rules, and orders governing the provision of local exchange telecommunications services in the State of Tennessee.
- 2. The Applicant's Small and Minority Owned Business Plan is attached as **Exhibit D**.
- 3. Subsequent to the approval of its *Application*, BTC will file any necessary tariffs prior to providing the proposed service covered by this *Application*.
- 4. A certificate of service stating that notice of this *Application* has been served on all incumbent local exchange telephone companies in Tennessee is attached hereto.
- 5. BTC is aware of its obligation to comply with the requirements of county-wide calling, as set forth in Tenn. Code Ann. § 65-21-114.
- 6. BTC does not currently collect deposits from first time customers. To the extent that BTC requires a deposit for the establishment of service, the same shall be implemented in compliance with the Commission's rules and regulations and as properly provided in and consistent with tariffs.

V. PUBLIC INTEREST STATEMENT

1. The grant of this *Application* will further the public interest by expanding the availability of telecommunications services throughout the State of Tennessee. Specifically, Tennessee consumers will benefit directly through the use of the competitive local services to be offered by BTC. BTC will provide more choices for consumers. Further, the public will benefit indirectly because the competitive presence of BTC will increase the incentives for telecommunications providers to operate more efficiently, offer more innovative services, reduce

prices, improve the quality and coverage of their services, and increase investment in broadband infrastructure.

2. The granting of this *Application* would be consistent with the public policy of the State of Tennessee, as set forth at Tenn. Code Ann. § 65-4-123, "to foster the development of an efficient, technologically advanced statewide system of telecommunications services by permitting competition in all telecommunications services market[.]"

VI. <u>CONCLUSION</u>

For the foregoing reasons, BTC Communications, LLC respectfully requests the Commission to grant its Certificate of Public Convenience and Necessity on an expedited basis and authorize it to provide telecommunications services, as requested herein, throughout the State of Tennessee.

SMALL AND MINORITY-OWNED TELECOMMUNICATIONS BUSINESS PARTICIPATION PLAN

Pursuant to T.C.A. §65-5-112, as amended, BTC Communications, LLC ("BTC") submits this small and minority-owned Telecommunications business participation plan (the "Plan") along with its Application for a Certificate of Public Convenience and Necessity to provide competing intrastate and local exchange services in Tennessee.

I. PURPOSE

The purpose of T.C.A. §65-5-112 is to provide opportunities for small and minority-owned businesses to provide goods and services to Telecommunications service providers. BTC is committed to the goals of T.C.A. §65-5-112 and to taking steps to support the participation of small and minority-owned Telecommunications businesses in the Telecommunications industry. BTC will endeavor to provide opportunities for small and minority-owned Telecommunications businesses to compete for contracts and subcontracts for goods and services. II. **DEFINITIONS**

Minority-Owned Business. Minority-owned business shall mean a business which is

solely owned, or at lease fifty-one percent (51%) of the assets or outstanding stock of which is

owned, by an individual who personally manages and controls daily operations of such business,

and who is impeded from normal entry into the economic mainstream because of race, religion,

sex or national origin and such business has annual gross receipts of less than four million dollars

(\$4,000,000).

Small Business. Small Business shall mean a business with annual gross receipts of less

than four million dollars (\$4,000,000).

37 Q. WHAT IS BTC SEEKING IN ITS APPLICATION IN THIS DOCKET?

BTC is currently seeking authority to provide intrastate telecommunications services throughout the State of Tennessee as a Competitive Local Exchange Carrier ("CLEC"). BTC is aware of all the requirements necessary in order to expand its offerings statewide as a CLEC. At this time, BTC only intends to expand its offerings from time to time as business conditions warrant. To the extent that any rural incumbent local exchange carrier possesses an exemption or suspension under Section 251(f) of the Federal Communications Act (the "Act") that would apply to BTC's proposed expanded operations, BTC does not seek interconnection under Section 251(c) at this time, nor does

BTC seek at this time to challenge any such exemption from any of the other obligations specified in Section 251(c) of the Act.

BTC will offer directory services and E911 in the proposed service area.

WHY IS BTC SEEKING EXPANDED AUTHORITY?

BTC desires to expand its offerings of telecommunications services throughout the State of Tennessee in order to provide more consumers with increased carrier choices, competitive pricing, increased reliability, responsiveness, and innovation. The granting of this *Application* will provide significant benefits to Tennessee consumers and thereby serve the public interest.

Q. DOES BTC MEET THE STATUTORY REQUIREMENTS SET FORTH IN TENN. CODE ANN. § 65-4-201(c)?

Yes. As set forth in the Application, Bledsoe, the sole owner of TTC, which is the sole owner of BTC, is a seasoned, experienced telecommunications provider in the State of Tennessee and certainly has the managerial, financial and technical abilities required under Tennessee law. Our Application evidences that we have valuable experience as a telecommunications provider over Bledsoe's many decades of exceptional services. This experience provides BTC with the foundation necessary to provide the proposed telecommunications services and to further serve Tennessee's telecommunications consumers. As supported by **Exhibit A** to the Application, BTC is managerially and technically qualified to provide telecommunications services statewide. As shown in this exhibit, BTC's principal corporate offices, board members and staff have substantial managerial and technical experience in the relevant areas, including utility operations, utility customer service and utility marketing. This experience provides BTC with the
