¹ At the time that the agency found that a bond of \$120,000 would provide sufficient financial security, the company's most recent annual report (2017) showed total annual revenue (after deducting tap fees and developer contributions) of \$582,670. See Pre-filed Testimony of Bruce Meyer at p. 3. The company's annual revenue for 2019 (after deducting tap fees, developer contributions, inspection and locate fees) was \$579,000, according to Mr. Meyer. Therefore, pursuant to Rule 1220-04-13-.07(2)(c), the current bond amount remains sufficient and there is no need for the company to petition the Commission for alternative relief.
