Re: Notification of Intent to Operate Pursuant to Market Regulation by Matrix Telecom, LLC

Dear Ms. Dillon:

On behalf of Matrix Telecom, LLC ("Matrix"), this letter advises the Tennessee Regulatory Authority ("Authority") that Matrix elects to operate under market regulation pursuant to T.C.A. Section 65-5-109 enacted in May 2009. In Tennessee, Matrix is authorized to provide facilities-based and resold competitive local exchange telecommunications service by Orders issued in Docket No. 07-00003 on May 22, 2007 and Docket No. 05-00083 on June 30, 2005, respectively, and resold interexchange telecommunications service by the Order issued in Docket No. 95-03215 on October 13, 1995. Consistent with this election, Matrix withdraws its retail local exchange and interexchange tariffs, Tariff Nos. 1 and 3, effective upon receipt of this letter. Matrix retains its Tariff No. 2 with respect to the switched access services, which remains in effect.
