Q: Please state your name and business address.

A: My name is Kenneth Hay. My business address is 200 Noah Drive, Franklin Tennessee,
37604.

Q: By whom and in what capacity are you employed?

A: I am employed by Atmos Energy Corporation, Kentucky/Mid-States Division ("Atmos Energy") as Operations Supervisor for the Franklin area of operations which includes Atmos Energy's operations in the City of Franklin, Tennessee.

Q: Please describe your work history with Atmos Energy.

A: I have been employed by Atmos Energy for 33 years. I began my career as a Marketing Representative and have held various positions in Atmos Energy with increasing responsibilities. I have been in my current position for 13 years.

Q: Have you previously offered testimony in any regulatory proceedings?

1 A: Yes. I have provided testimony to this Commission in various dockets seeking approval
2 of franchise agreements.

3 **Q: What is the purpose of your testimony in this case?**

4 A: I am testifying on behalf of Atmos Energy in support of the petition filed for approval of
5 the extension of a negotiated franchise agreement with the City of Franklin, Tennessee in
6 Docket No. 18-00088. I am also adopting the testimony of Company witness Matthew
7 Davis, previously filed in this Docket, and will be testifying on his behalf.

8 **Q: Are you familiar with the testimony submitted by Company witness Matthew Davis**
9 **in this docket?**

10 A: Yes, I have reviewed his testimony and am familiar with its contents.

11 **Q: Do you adopt the testimony of Company Witness Matthew Davis as your own in this**
12 **docket?**

13 A: Yes. I adopt the testimony as my own and am willing to answer any questions regarding
14 the contents of that testimony.

15 **Q: In your capacity as Operations Supervisor for the Franklin, Tennessee region of**
16 **Atmos Energy, are you familiar with the natural gas distribution system operated by**
17 **Atmos Energy in Franklin, Tennessee?**

18 A: Yes. I am familiar with the operation in Franklin, Tennessee as well as the operations in
19 the other surrounding communities that are served by the Atmos Energy system.

20 **Q: Are you familiar with the franchise negotiation between Atmos Energy and the City**
21 **of Franklin?**

1 A: Yes. I am familiar with the negotiations that have occurred between Atmos Energy and
2 the City of Franklin as well as the negotiated agreement that the two parties are submitting
3 for approval before the Commission.
