# MOTION TO ALLOW WITNESS TO APPEAR AND PARTICIPATE AT HEARING BY TELEPHONE

The Petition of Kentucky Utilities Company ("KU" or the "Company") in the above-captioned matter is scheduled to be heard at the Tennessee Public Utility Commission's ("Commission") Agenda Conference at 1:00 P.M. (CDT) on May 20-21, 2019.

Pursuant to T.C.A. §4-5-312(c), KU submits this *Motion to Allow Witness to Appear and Participate at Hearing by Telephone* ("Motion"). As grounds for its Motion, KU states as follows: T.C.A. §4-5-312(c) addresses electronic participation and reads:

In the discretion of the administrative judge or hearing officer and agency members and by agreement of the parties, all or part of the hearing may be conducted by telephone, television or other electronic means, if each participant in the hearing has an opportunity to participate in, to hear, and, if technically feasible, to see the entire proceedings while taking place.

Pursuant to this statute, KU respectfully requests that its witness be allowed to participate in the hearing on its Petition via telephone. KU's corporate offices and the business office of KU's witness in this matter, Robert M. Conroy, Vice President – State Regulation and Rates, are located in Louisville, Kentucky. Mr. Conroy can appear at and participate by telephone conference in the Commission's Agenda Conference, and offer a summary of his testimony and

answer any questions without prejudice to the Commission's consideration of KU's Petition.

There are no other participants in this proceeding. Under these circumstances the travel time for the witness is burdensome and inefficient.

If the Motion is granted, KU agrees that the appearance and participation of its witness by telephone will be subject to the following conditions:

- 1. KU shall be required to secure a licensed Notary Public in good standing in the Commonwealth of Kentucky (the jurisdiction where the testimony is to be given) who will be in the same physical location with Mr. Conroy while he is providing testimony.
- 2. The Notary Public obtained by KU shall request the witness to provide verifiable identification for purpose of providing sworn testimony via telephone at the hearing before the Tennessee Public Utility Commission.
- 3. The Notary Public obtained by KU shall be duly authorized to administer the testimonial oath and shall administer such oath during the hearing and remain physically present with the witness at all times during the witness's testimony and until the witness is excused from examination by the Commission or Hearing Officer.
- 4. After the hearing, the Notary Public shall prepare and sign an affidavit, which bears the official seal of the Notary Public, affirming: (1) the proven identity of the witness, (2) the fact that the Notary Public properly administered the testimonial oath to such person, and (3) that the testimony given by the sworn witness was in accordance with ethical and legal standards, as observed by the Notary Public. In addition, the testifying witness shall sign a conforming Witness Certification in the form attached hereto or in such other format ordered by the Commission.

5. The original Witness Certification and Notary Public Affidavit shall be postmarked within five days of the hearing and received by the Commission's Docket Manager via postage-paid U.S. Mail or other courier.

WHEREFORE, Kentucky Utilities Company respectfully requests that the Commission enter an Order granting KU's Motion to allow its witness Robert M. Conroy, Vice President – State Regulation and Rates, to participate by telephone in the Commission Conference scheduled for May 20-21, 2019.
