**PUBLIC NOTICE**

Notice is hereby given that Atmos Energy Corporation (the Company) filed a Petition with the Tennessee Public Utility Commission (TPUC) on January 7, 2019 in Docket 19-00004, seeking approval pursuant to Tenn. Code Ann. 65-4-107 of a new franchise agreement with the City of Woodland Mills. This franchise agreement grants the Company the non-exclusive rights, authority, privilege and franchise to erect, construct, reconstruct, maintain and operate a natural gas plant or plants for the manufacturing and processing of any and all kinds of gas and for the distribution and transmission of natural gas and for the installation and maintenance of mains, pipes, pipelines, distribution lines, and other equipment necessary or incidental to distribution and transmission of said gas upon across, along and under the highways, streets, avenues, roads, alleys, lanes and other public grounds of the City. There is no franchise fee associated with the agreement. The franchise and the rights granted shall take effect upon approval of the Tennessee Public Utility Commission and shall continue in force for a term of twenty (20) years. The matter has been set for hearing on February 19, 2019 beginning at 1:00 p.m. CST in the TPUC's hearing room on the ground floor of the Andrew Jackson Staff Office Building at 500 Deaderick Street, Nashville, Tennessee.
