ORDER APPROVING PETITION FOR REVIEW OF CENTRAL OFFICE CODE DENIAL

This matter is before the Hearing Officer of the Tennessee Public Utility Commission (the "Commission" or "TPUC"), upon the *Petition of Teleport Communications of America*, *LLC-TN for Review of Central Office Code Denial* ("*Petition*") filed by Teleport Communications of America LLC-TN ("TCAL" or the "Company") on January 9, 2019.

TCAL is a telecommunications public utility subject to the jurisdiction of the Commission that provides local exchange telecommunications services in the State of Tennessee. In its *Petition*, TCAL asserts that on or about December 19, 2018, it submitted an application to NeuStar, the Number Pooling Administrator, for the assignment of one (1) Code (10,000 numbers) in the 615/629 area code for the Smyrna Rate Center. TCAL requested these numbers in order to fulfill an order for a customer who requested a block of 3,000 numbers to serve

Stonecrest Medical Center, with the remaining numbers to be used for pool replenishment.² TCAL indicates in its *Petition* that it does not have 3,000 numbers available in its inventory to satisfy the customer's request, currently only having 1,140 numbers available across two blocks.³

NeuStar's Central Office Code (NXX) Assignment Guidelines ("NXX Guidelines") permit the assignment of additional codes only after an applicant demonstrates that its rate center has a 75% utilization rate and exhaustion of existing numbering inventory does not exceed six months.⁴ At the time of TCAL's code request, the Smyrna Rate Center had a utilization rate of approximately 42.05% and a months-to-exhaust ratio of approximately 509 months.⁵ Therefore, because the rate center's current utilization rate and months-to-exhaust ration do not meet the criteria in the NXX Guidelines, NeuStar denied TCAL's application.⁶

The Federal Communications Commission ("FCC") has authorized the Commission to review NeuStar's decision to deny a numbering application. The FCC has further stated that a state commission may overturn a decision of the Numbering Pooling Administrator when "a carrier demonstrates that it has received a customer request for numbering resources in a given rate center that it cannot meet with its current inventory." Upon consideration of the facts contained in the record, the public interest, and the Commission's charge to foster competition in the telecommunications industry, the Hearing Officer agrees that TCAL's request should be approved.

IT IS THEREFORE ORDERED THAT:

- 1. The Number Pooling Administrator's decision to deny Teleport Communications of America, LLC-TN's application for additional numbering resources, as set forth in its *Petition* for Review of Central Office Code Denial and discussed herein, is reversed.
- 2. The Number Pooling Administrator¹⁰ is directed to provide one (1) Code (10,000 consecutive numbers) to Teleport Communications of America, LLC TN to meet the specific requirements of its customer within the 615/629 area code in the Smyrna Rate Center for Switch Identification No. NSVLTNWMWMD.
