Dear Mr. Mobeen,

The Commission has received your request to voluntarily cancel the Certificate of Public Convenience and Necessity granted to City Communications, Inc. on May 9, 2019. Before we can accommodate your request and terminate your operating authority in good standing, the company's outstanding fees must be satisfied. For each year that it has maintained an active CCN to operate in the State of Tennessee, City Communications, Inc. has failed to remit its inspection fee payments. As a result, in addition to the annual fee, pursuant to Tenn. Code Ann. § 65-4-308, a **penalty of 10% per month** or fraction thereof, is assessed from April 1<sup>st</sup> of the year it was due through the date that payment is postmarked. Our Fiscal Office has mailed a courtesy reminder each year and additional correspondence notifying you of this ongoing delinquency.

Attached are the required forms that must be completed and filed with your payment. Failure to pay the outstanding fees may result in further legal action, assessment of violation of Tennessee law, and additional civil penalties. Please contact Dori Simpson in our Fiscal Office at 615-770-6867 to discuss your account status, payment, and assistance completing the attached forms.
