The original and four (4) copies of this letter are submitted on behalf of Birch Communications, LLC ("Company") to notify the Tennessee Public Utility Commission ("Commission") that the Company is changing its name to Fusion Cloud Services, LLC effective April 1, 2019. The Company is authorized as a Competing Telecommunications Service Provider pursuant to Docket 99-00644 and filed Notice of Intent to Operate Pursuant to Market Regulation in January 2018.
