Re: Network Billing Systems, L.L.C. Name Change Notice

Dear Chairman Morrison:

Pursuant to Rule 1220-4-1.08, Network Billing Systems, L.L.C. hereby notifies the Tennessee Public Utility Commission ("Commission") that the Company is changing its name from Network Billing Systems, L.L.C. to **Fusion LLC dba Fusion Connect LLC**, effective April 1, 2019.<sup>1</sup> A copy of the Company's Tennessee Secretary of State name and assumed name registration is attached.

The Company maintains authority to provide resold telecommunications services in the State of Tennessee.<sup>2</sup> The Company provides service exclusively to commercial subscribers. Subscribers are being notified of the name change via bill message, also attached. This change in corporate name will have no effect on the services offered to Tennessee subscribers. The Company respectfully requests that the Commission amend the Company's authority and Commission records to reflect the Fusion LLC dba Fusion Connect LLC name, as appropriate.


