- 1. Is it Cartwright Creek's intention to completely surrender its CCN and not provide and/or operate any wastewater service systems in Tennessee?
- 2. Cartwright Creek holds the SOP for the Hardeman Springs wastewater treatment system, which has been constructed and has been inspected by TDEC. Is it Cartwright Creek's intent to continue to hold a CCN to operate the wastewater system at the Hardeman Springs Subdivision or is it included in the sale? If it is included, please identify the language in the contract specifying its inclusion.
- 3. State the monthly service rates currently being assessed to customers within the Hardeman Springs Subdivision and identify the existing tariff that specifies these charges.
- 4. Provide a copy of the Sewer and Wastewater Treatment System Service Agreement between Propst Hardeman Springs, LLC and Cartwright Creek, LLC dated October 24, 2018.
- 5. State whether Cartwright Creek holds a deed for the land, the treatment system and drip fields, and title to the wastewater treatment and collection system at the Hardeman Springs subdivision.
- 6. If approved by the Commission, is it Cartwright Creek's intention to transfer the Troubadour Club subdivision and the two new parcels requested in Docket No. 19-00042 to Limestone within the context of the pending sale?
- 7. Customer Deposits were not identified in the Pro Forma financial statements filed with the Petitions for First Round or Limestone; however, Customer Deposits are mentioned in the contract (Exhibit D). Is it Cartwright Creek's intention to refund the existing customer deposits (\$138,916 based on the 2018 Annual Report filed with the Commission) prior to the completion of the sale, or will the customer deposits be transferred to Limestone at the time of a completed sale?
- 8. Please provide a completed copy of the exhibits to the *Agreement for Sale of Utility System*, Exhibits A,B,C and D. In addition, identify each by owner and Grantor for Cartwright Creek, LLC, Cartwright Creek Utility Company, Inc. and Cartwright Creek Utility District.
- 9. Provide any document evidencing compliance with provisions of the Company' Operating Agreement concerning sale and/or transfer of membership shares.
- 10. Provide a complete listing of all assets to be transferred to Limestone and any assets to be retained by Cartwright Creek. Identify such assets of Cartwright Creek which are contained in the 2018 Annual Report filed at the Commission.

- 11. Provide a complete listing of any liabilities that will not be transferred to Limestone. If there are liabilities that will not be transferred, please identify the responsible party for these liabilities.
- 12. Please explain the change in "Other liabilities" from \$349,728 in 2017 to \$849,672 in 2018 as stated in Cartwright Creek's Annual Reports filed at the Commission (Page F-4).
- 13. Please explain the change in Capital from \$564,887 in 2017 to \$200 in 2018 as stated on Cartwright Creek's Annual Reports filed at the Commission (Page F-4).
- 14. Please discuss in detail the process utilized by Cartwright Creek and Limestone for reaching an agreed purchase price for Cartwright Creek's wastewater system. Please include any calculations, studies and other relevant information.
- 15. Please file the most recent interim financial statements for both Cartwright Creek, LLC and Sheaffer Wastewater Solutions, LLC.
