- 1. Provide a copy of all executed contracts in which Cartwright Creek, LLC and/or any of its affiliates has agreed to provide wastewater services to Troubadour development (formerly known as Hideaway and formerly known as Stillwater) (hereinafter the "Development"). No contract has been filed for the Development, nor has any special contract been filed for approval for the Development*.
 - *(The Development was the subject of a TPUC Docket No. 16-00097, In re: Joint Petition of Cartwright Creek, LLC and Arrington National Development, LLC for Approval of a Special Contract. The Joint Petition of Cartwright Creek, LLC and Arrington National Development, LLC for Approval Nunc Pro Tunc of Special Contract ("Petition"), filed on August 22, 2016, sought TPUC approval for the contract between Cartwright Creek and Arrington for Cartwright Creek to provide wastewater services for the Development, then known as The Hideaway. The Petition further stated that as of August 15, 2016 Cartwright Creek had not yet been required to provide any wastewater services to The Hideaway and the negotiated benefits derived per the terms of the special contract had not yet been realized by The Hideaway. The Petition was subsequently withdrawn by order entered on February 28, 2018, with a directive to file petitions seeking approval of special contracts in advance of execution.)
- 2. Provide a copy of the deed or deeds for the real property associated with the treatments system and drip field for the Development, whether from the current developer or developers associated with the Development when known as Hideaway and/or Stillwater. Include a copy of any deed for any additional real property required for additional drip field(s) or other improvements necessary for the newly enhanced wastewater system for the Troubadour development.
- 3. File a copy of any contract between Cartwright Creek and Discovery Land Company/Arrington Property Holdings, LLC, (the new Troubadour Club Developer) in TPUC Docket No. 07-00180, Cartwright Creek's original CCN docket for the Development, as soon as possible.
- 4. State whether Cartwright Creek intends to collect the \$10,000 tap fee approved in TPUC Docket No. 19-00034 from all customers in all subdivisions prior to connecting to a wastewater system owned by Cartwright Creek serving such customers and/or subdivisions?
- 5. Identify all connections that are currently billed for monthly sewer service on a copy of the map provided to the Commission on June 21, 2019 on behalf of Cartwright Creek. For sake of efficiency, the circles identifying the lots on the above reference map can be filled in for those connections currently receiving a monthly bill for service.
- 6. Provide a list of the itemized costs recorded, or expected to be recorded, on Cartwright Creek's financial reports as Contribution in Aid of Construction for Hardeman Spring. Include the market value of the land for the drip field at Hardeman Springs.
