DATA REQUEST

On March 29, 2019, King's Chapel Capacity, LLC ("King's Chapel") filed with the Commission a petition to expand its service territory to include the Hill and Roberts Parcels in Williamson County, Tennessee (Docket No. 19-00043). According to maps on file with the Commission and King's Chapel's State Operating Permit with TDEC, it appears the proposed service area in King's Chapel's petition may be located within a portion of the Milcrofton Utility District. According to Commission records, Tennessee Wastewater Systems, Inc. ("TWWS" or "Company") was granted a certificate to provide sewer service within a large portion of the Milcrofton Utility District service area in Commission Docket No. 97-01393.¹

1. Please state whether the Hill and Roberts Parcels are within service area granted to TWWS. If so, please specify and reference such authority.
2.
 - (a) If the Hill and Roberts Parcels are within TWWS' certificated service area, please state whether the Company is providing service within these two parcels.
 - (b) If TWWS is not serving these parcels, please state whether the Company has the requisite facilities in place to provide sewer service to these areas.
 - (c) If TWWS is currently capable of serving these areas, identify all existing facilities that are in place, along with any additional infrastructure, that would be needed to provide service.
 - (d) State whether TWWS has acquired the necessary easements and sufficient land and all other necessary local and state approvals to serve the Hill and Roberts Parcels.
3. In the event that the Hill and Roberts parcels are within TWWS' certificated service area and TWWS is not serving, or is unable or unwilling to serve these two parcels, state whether the Company will relinquish the parcels.
