 - (b) Why does the product of applying the allocation factor (11.3661504%) to NUC's Account 921 along with adding the amount in 921.16 not match the amount recorded in Account 921 on NTN's general ledger? Discuss the discrepancies for the months of March, June, July, August, September, October, November, and December.

RESPONSE: CORRECTION. The previous response to Q. 1-5 should not have an attachment.

The response to Q. 1-5 (a) & (b) is correct otherwise. The correct response is restated below for convenient reference ("SEE ATTACHMENT" omitted from previous response).

- a. Account 921.16 is direct charged to Tennessee. Accounts 921.15, .28, and .46 are not charged to Tennessee. All other 921 accounts are allocated between all four jurisdictions
 b. 1) Accounts .15, .28, and .46 would need to be removed.
- 2) Generally, Navitas does not go back and rebill for small changes; thus in a vendor invoice comes in after about the 21st of the following month NUC does not rebill the various jurisdictions and likewise if something gets miss classed and subsequently moved, for example at the close of

RESPONSE: The 2018 NUC total for account 924 is \$139,797 x 11.3661504% allocated to TNNG = \$15,890. However, TNNG allocation from NUC is \$16,308. This comports with the NUC practice generally not to rebill for adjustments after the billing date. From time to time (i.e. – a piece of equipment is removed from insurance) NUC will receive a refund of premium. The \$418 overallocation reflects the aforementioned.
