Comes the Consumer Advocate Unit in the Financial Division of the Office of the Attorney General (Consumer Advocate), pursuant to Tenn. R. Civ. Proc. 7.02 and Tenn. Comp. R. & Regs. 1220-1-2-.06, and respectfully moves the Tennessee Public Utility Commission to exclude any reference to or use by any witnesses of the Joint Applicants of the following items/documents: Case Study 1; Case Study 2; Case Study 3; and videos of Elm Hills Utility Operating Company-CSWR and Indian Hills Utility Operating Company Transformation. These items/documents were filed by Joint Applicants for the first time on August 5, 2020. No prior reference to these documents was made by any witness of the Joint Applicants prior to August 5, 2020.

The Consumer Advocate objects to any reference to or use of these items/documents by any witness of the Joint Applicants. In particular, these items/documents were not referred to in

the testimony of Josiah Cox; therefore, it would be inappropriate for him to refer to these items/documents in the summary of his testimony.
