## Docket No. 19-00072 - Petition Of Atmos Energy Corporation for Approval of Agreement with Brown-Forman Corporation d/b/a Jack Daniel Distillery

Data Responses of Atmos Energy to Data Requests of October 16, 2019

1. Is Jack Daniel Distillery "Jack Daniel" a current customer of Atmos or was it a customer prior to the negotiation of this Agreement? If so, under what tariff was Jack Daniel served?

Jack Daniel Distillery is a current Customer of Atmos Energy. It is served under Rate Schedule 250.

2. The Agreement states on page 2 that the Extension of Facilities will be approximately 21,000 feet and connect Enbridge Pipeline to the "company's existing natural gas distribution system near the entrance to Jack Daniel's Distillery and customer's existing meter station." Explain the reason a connection to the interstate pipeline is necessary to serve Jack Daniels under the new Agreement when Atmos already has its distribution system in close proximity to Jack Daniel's meter.

Atmos Energy's Lynchburg distribution system is served by East Tennessee Natural Gas' (ETNG) Fayetteville Lateral. This lateral does not have enough capacity to serve Jack Daniel's increasing natural gas requirements. In order to meet Jack Daniel's requirements, a new interconnect with ETNG's main line 21,000 feet to the north of the distribution system was required.
