ORDER TO OPEN A RULEMAKING PROCEEDING TO PROMULGATE RULES FOR PUBLIC COMMENT

This matter came before Chair Robin L. Morrison, Vice Chair Kenneth C. Hill, Commissioner Herbert H. Hilliard, Commissioner John Hie, and Commissioner David F. Jones of the Tennessee Public Utility Commission (the "Commission"), the voting panel assigned to this docket, during a regularly scheduled Commission Conference held on September 9, 2019. In a letter dated August 7, 2019, Chairman Martin Daniel of the State of Tennessee House of Representatives Government Operations Committee expressed concerns that certain state "administrative entities have 'policies' or rules in place that make it cumbersome or difficult for members of the public to address the agencies during meetings." Chairman Daniel further urged all state administrative entities to move to "adopt regulations that enable members of the public to simply and easily address your board at its regular or special meetings."

During the Commission Conference, the Commissioners voted unanimously to initiate a rulemaking proceeding for the purpose of promulgating rules for the orderly process of receiving public comments during public meetings and hearings.

IT IS SO ORDERED.

Dear Chairman Morrison,

I serve as Chairman of the House Government Operations Committee for the 111th General Assembly.

Two of the areas of emphasis for the Committee are accountability and transparency in and surrounding our state agencies, including councils, boards, and commissions. In that regard, I have noticed that many of these administrative entities have "policies" or rules in place that make it cumbersome or difficult for members of the public to address the agencies at their meetings. Examples of these include unreasonable advance "sign up" requirements, limitations as to the content of the subject matter, and unreasonably short time periods for one to speak. Reasonable limitations on speech at these meetings are expected and necessary, but some of these existing rules actually obstruct accountability and transparency of the governing boards. We, as representatives, are accountable to our constituents, and we want our governing boards to be accountable and responsive to Tennesseans. Listening to Tennesseans is a big part of that.

This issue will be an area of inquiry in connection with your next comptroller audit and sunset hearings of administrative entities. If you have not already done so, I encourage you to move to adopt regulations that enable members of the public to simply and easily address your board at its regular or special meetings. Certainly, your receptiveness to public comment will be a factor in recommending, or not, the continuation of your agency.

We are proud of our Tennessee agencies, and we, the legislature, appreciate your service. Please do not hesitate to contact me or your respective legislator if you have any questions regarding this, or if we can otherwise be of service.
