

**DIRECT TESTIMONY OF
A. WAYNE ALLEN
ON BEHALF OF KINGSPORT POWER COMPANY
D/B/A AEP APPALACHIAN POWER
BEFORE THE TENNESSEE PUBLIC UTILITY COMMISSION
DOCKET NO. 19- 00106**

1 **Q. PLEASE STATE YOUR NAME, BUSINESS ADDRESS AND POSITION.**

2 A. My name is A. Wayne Allen. My business address is 1 Riverside Plaza,
3 Columbus, Ohio 43215. I am an Accounting Senior Manager for American
4 Electric Power Service Corporation (AEPSC), a wholly owned subsidiary of
5 American Electric Power Company, Inc. (AEP). AEP is the parent company of
6 Kingsport Power Company (KgPCo or the Company).

7 **Q. PLEASE SUMMARIZE YOUR EDUCATIONAL AND EMPLOYMENT**
8 **BACKGROUND.**

9 A. I graduated summa cum laude with a Bachelor of Science Degree in Accounting
10 from Radford University in 1985. I received a Master of Business Administration
11 Degree with a concentration in Finance from Virginia Polytechnic Institute and
12 State University (Virginia Tech) in 1988. I was employed at Bell Atlantic (now
13 Verizon Communications) in 1988 as an assistant manager in the Corporate
14 Accounting department. In 1990, I joined Appalachian Power Company (APCo)
15 in Roanoke, Virginia as an Associate Staff Accountant. In 1995, I was promoted
16 to Staff Accountant, with my primary responsibility being the development of
17 accounting information for base rate case filings in Virginia and West Virginia
18 including the preparation of schedules and ratemaking adjustments and the

1 development of jurisdictional federal income taxes. In 1998, I transferred to the
2 Regulatory Services department of APCo as a Rate Analyst. My responsibilities
3 included the development of jurisdictional cost of service studies and associated
4 allocation factors for APCo. In 2000, I transferred to the AEPSC as a Staff
5 Accountant in the Accounting Policy and Research department where I was
6 responsible for researching Generally Accepted Accounting Principles (GAAP),
7 developing the accounting for new transactions and designing accounting policies.
8 In 2002, I joined the Regulatory Accounting Services Department of Corporate
9 Accounting as a Staff Assistant and in 2004, I was promoted to the position of
10 Administrator in that same Department. In 2006, I was promoted to Principal
11 Regulatory Accounting Consultant and in 2007, I was promoted to Regulatory
12 Accounting Case Manager. In 2019, I was promoted to my current position.

13 **Q. WHAT ARE YOUR RESPONSIBILITIES AS ACCOUNTING SENIOR**
14 **MANAGER?**

15 A. My responsibilities include providing the AEP electric operating subsidiaries,
16 such as KgPCo, with accounting support for regulatory filings including the
17 preparation of cost of service adjustments, accounting schedules and testimony.
18 Also, I monitor regulatory proceedings and legislation for accounting implications
19 and assist in determining the appropriate regulatory accounting treatment.

20 **Q. HAVE YOU PREVIOUSLY TESTIFIED IN ANY REGULATORY**
21 **PROCEEDING BEFORE THIS OR ANY OTHER COMMISSION?**

22 A. Yes. I testified before this Commission in KgPCo Docket No. 17-00032 and I
23 presented testimony on behalf of KgPCo in Docket Nos. 16-00001, 17-00143 and

1 18-00125. I have also testified on behalf of APCo before the Virginia State
2 Corporation Commission and the Public Service Commission of West Virginia.
3 In addition, I have submitted testimony on behalf of Indiana Michigan Power
4 Company (I&M) before the Michigan Public Service Commission. Like KgPCo,
5 APCo and I&M are electric operating subsidiaries of AEP.

6 **Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY IN THIS**
7 **PROCEEDING?**

8 A. The purpose of my testimony is to:

- 9 • Support the under-recovery of Targeted Reliability Plan and Major Storm
10 (TRP&MS) costs incurred during the 12-month period from October 2018
11 through September 2019 (Review Period) in addition to those unrecovered
12 TRP&MS costs incurred during the period from October 2017 through
13 September 2018 that were the subject of KgPCo Docket No. 18-00125.
- 14 • Identify the revenues recorded from the TRP&MS Rider implemented on
15 June 1, 2019.
- 16 • Provide an attestation that the Rider revenues, costs and expenses included
17 in this Petition are complete and accurate and reflect actual amounts on the
18 Company's books and records.
- 19 • Provide supporting information for TRP&MS costs incurred during the
20 Review Period as agreed in the Stipulation and Settlement Agreement
21 (Settlement Agreement) approved by the Commission in Docket No. 18-
22 00125.

23 **Q. WHAT EXHIBITS ARE YOU SPONSORING?**

1 A. I am sponsoring the following exhibits:

- 2 • KgPCo Exhibit No. 1 (AWA) is a summary of the monthly over or under-
3 recovery of TRP&MS costs for the Review Period.
- 4 • KgPCo Exhibit No. 2 (AWA) is a schedule of revenues recorded from the
5 TRP&MS Rider.
- 6 • KgPCo Exhibit No. 3 (AWA) is an attestation regarding the requested
7 TRP&MS costs and expenses.
- 8 • KgPCo Exhibit No. 4 (AWA) is a summary by category of TRP&MS
9 Operation and Maintenance (O&M) expenses incurred during the Review
10 Period and a supporting list of invoices paid related to such expenses.
- 11 • KgPCo Exhibit No. 5 (AWA) is voluminous general ledger detail of all
12 TRP&MS O&M expenses incurred during the Review Period, which is
13 being supplied on disk.

14 **Q. WHAT IS THE OVER OR UNDER-RECOVERY BALANCE OF TRP&MS**
15 **COSTS THAT THE COMPANY IS REQUESTING TO INCLUDE IN THE**
16 **UPDATED TRP&MS RIDER?**

17 A. The Company is requesting to recover \$6,683,782 of deferred actual TRP&MS
18 under-recovered costs as of September 30, 2019 recorded on KgPCo's books in
19 Account 1823426, TRP&MS Under Recovery. The requested \$6,683,782 is
20 comprised of an under-recovery of \$5,613,024 for TRP costs and an under-
21 recovery of \$1,811,494 for major storm expenses offset by TRP&MS Rider
22 revenues of \$740,736 collected during the four-month period from June through
23 September 2019. The \$5,613,024 and \$1,811,494 under-recovery balances at

1 September 30, 2019 are net of the annual level of TRP costs and major storm
2 expenses recovered through base rates of \$903,372 and \$392,376, respectively.

3 The annual level of TRP&MS costs included in current base rates was determined
4 by Commission Order, dated October 19, 2016, in Docket No. 16-00001.

5 **Q. ARE YOU SPONSORING AN EXHIBIT THAT SUMMARIZES THE**
6 **COST COMPONENTS AND RECOVERY OF THE TRP&MS COSTS**
7 **THROUGH SEPTEMBER 30, 2019?**

8 A. Yes. KgPCo Exhibit No. 1 (AWA) summarizes the monthly TRP&MS costs
9 incurred for the period October 2018 through September 2019, the monthly
10 TRP&MS costs included in base rates, the monthly TRP&MS Rider revenues
11 recorded and the resulting under-recovery at the end of each month. Note that
12 this exhibit shows a beginning under-recovery balance in column (p) at
13 September 30, 2018 of \$2,330,677, which the Commission approved for recovery
14 in Docket No. 18-00125 through the TRP&MS Rider beginning June 1, 2019.
15 The other beginning balances as of September 30, 2018 shown in this exhibit are
16 the same as the respective ending balances provided in KgPCo Exhibit No. 1
17 (AWA) in Docket No. 18-00125.

18 **Q. PLEASE DESCRIBE THE INFORMATION CONTAINED IN KGPCO**
19 **EXHIBIT NO. 1 (AWA).**

20 A. Columns (a) through (k) of KgPCo Exhibit No. 1 (AWA) provide monthly costs
21 incurred, costs recovered through base rates and the resulting under-recovery
22 related to the TRP and columns (l) through (n) provide monthly expenses
23 incurred, expenses recovered through base rates and the resulting under-recovery

1 related to major storms. The under-recovery balances shown in columns (k) and
2 (n) were reduced by the monthly TRP&MS Rider revenues shown in column (o)
3 beginning with June 2019. Column (p) provides the month-end net TRP&MS
4 under-recovery balances recorded on the Company's books in Account 1823426
5 and are the sum of the amounts shown in column (k) for the TRP and column (n)
6 for major storms reduced by the cumulative Rider revenues in column (o).

7 For the TRP, column (a) provides the monthly O&M expenses charged (or
8 credited) to the TRP projects. Column (b) provides the cumulative capital
9 additions charged to the TRP projects for capital investments incurred after
10 September 2017. Column (c) provides the accumulation of monthly depreciation
11 expense amounts, which during the Review Period are shown in column (h). The
12 depreciation rates used to calculate depreciation on the TRP projects are those
13 rates approved by the Commission in Docket No. 16-00001. The accumulated
14 deferred income taxes shown in column (d) reflect the difference between book
15 depreciation and accelerated tax depreciation. The net TRP capital additions
16 shown in column (e) are computed by subtracting columns (c) & (d) from column
17 (b) and are applied to the monthly carrying charge rate in column (f) to calculate
18 the pre-tax return on capital shown in column (g). The sum of columns (a), (g),
19 and (h) equal the total TRP costs shown in column (i). The monthly TRP costs
20 included in the development of the Commission approved base rates in Docket
21 No. 16-00001 shown in column (j) are compared to the total TRP costs from
22 column (i) to compute the cumulative under-recovery of TRP costs shown in

1 column (k) before consideration of TRP&MS Rider revenues shown in column
2 (o).

3 For major storms, the monthly O&M expenses charged (or credited) to a
4 KgPCo major storm project(s) during the Review Period are shown in column (l)
5 and these O&M expenses are the only major storm costs included in the
6 TRP&MS over/under-recovery. The monthly major storm O&M expenses
7 included in the development of the Commission approved base rates in Docket
8 No. 16-00001 shown in column (m) are compared to the expenses in column (l) to
9 compute the net under-recovery of major storm expenses shown in column (n)
10 before consideration of TRP&MS Rider revenues shown in column (o).

11 **Q. DO YOU HAVE A SCHEDULE SUMMARIZING THE TRP&MS RIDER**
12 **REVENUES RECORDED DURING THE REVIEW PERIOD?**

13 A. Yes. KgPCo Exhibit No. 2 (AWA) is a schedule of TRP&MS Rider revenues
14 recorded monthly on a billed and accrued basis effective for service rendered on
15 and after June 1, 2019 as approved by the Commission in Docket No. 18-00125.
16 This schedule provides the monthly billed Rider revenues along with the set-up of
17 the current month and reversal of the prior month unbilled revenues and any
18 estimated revenues. Estimated revenues are recorded whenever the actual month-
19 end billing information for certain large commercial and industrial customers is
20 not available until the following month.

21 **Q. IS THE COMPANY PROVIDING AN ATTESTATION REGARDING THE**
22 **COSTS AND EXPENSES REQUESTED IN THE UPDATED TRP&MS**
23 **RIDER?**

1 A. Yes. KgPCo Exhibit No. 3 (AWA) provides an attestation as required in the
2 TPUC's *Order Granting Petition* in Docket No. 17-00032. This attestation states
3 that Rider revenues, costs and expenses included in the Company's Petition in the
4 current docket are complete and accurate and reflect actual amounts recorded on
5 KgPCo's books and records during the 12-month period ended September 30,
6 2019.

7 **Q. ARE YOU SUPPORTING ANY OTHER INFORMATION THAT**
8 **RESULTED FROM THE APPROVED SETTLEMENT AGREEMENT IN**
9 **THE PRIOR TRP&MS PROCEEDING?**

10 A. Yes. KgPCo Exhibit Nos. 4 (AWA) and 5 (AWA) provide the same type of
11 information as set forth in Attachment 1 to the Settlement Agreement in Docket
12 No. 18-00125, along with supporting workpapers of invoices paid and details of
13 other incurred TRP&MS costs. KgPCo Exhibit No. 4 (AWA) is a summary
14 similar to Settlement Attachment 1 that lists the TRP&MS O&M expenses
15 incurred during the Review Period by various types of transactions such as
16 accounts payable invoices, intercompany billings and non-labor compatible unit
17 (CU) allocations. Compatible units are work management control processes to
18 administer projects and accumulate associated costs. KgPCo Exhibit No. 4
19 (AWA) also provides a supporting list of invoices paid including vendor names
20 related to such TRP&MS O&M expenses.

21 KgPCo Exhibit No. 5 (AWA) provides over 2,800 lines of general ledger
22 transaction details of all TRP&MS O&M expenses totaling \$5,973,588 incurred
23 during the Review Period for both invoiced and non-invoiced costs. The

1 Company is supplying the voluminous information reflected in this exhibit
2 electronically on a disk.

3 **Q. DID THE COMPANY EXPERIENCE ANY MAJOR STORMS DURING**
4 **THE REVIEW PERIOD?**

5 A. Yes. During the October 2018 through September 2019 period, there were two
6 new major storms that impacted KgPCo's customers as described by Company
7 witness Keeton. Also, there were some additional expenses incurred during this
8 period related to the July 20, 2018 major storm that was discussed in Docket No.
9 18-00125. The December 9, 2018 snowstorm was by far the more damaging of
10 the two major storms that occurred during the Review Period resulting in
11 \$2,048,800 of the total \$2,097,677 of major storm O&M expenses incurred. The
12 other major storm during the Review Period was a windstorm occurring on
13 February 24, 2019 that resulted in \$19,736 of O&M expenses, while \$29,141 of
14 additional O&M expenses were incurred related to the July 20, 2018 storm.

15 **Q. WHAT RATE DID THE COMPANY USE TO CALCULATE THE**
16 **RETURN ON TRP CAPITAL INVESTMENTS IN THIS PETITION?**

17 A. KgPCo used the same annual pre-tax carrying charge rate of 7.581% to calculate
18 the return on net capital investments that the Company used in the prior TRP&MS
19 docket for January 2018 and subsequent months. This 7.581% carrying charge
20 rate is consistent with the 8.738% annual rate approved by the Commission in
21 Docket No. 16-00001 except that the 7.581% reflects the reduction in the
22 corporate federal income tax rate from 35% to 21% effective January 2018. The
23 Company will continue to use the 7.581% pre-tax carrying charge rate in its

1 calculation of TRP&MS costs until a new capital structure/cost of capital is

2 approved in KgPCo's next base rate case.

3 **Q. DOES THIS CONCLUDE YOUR DIRECT TESTIMONY?**

4 **A.** Yes, it does.

A. Wayne Allen, being first duly sworn, deposes and says:

1. I am an Accounting Senior Manager for American Electric Power Service Corporation (“AEPSC”), a wholly-owned subsidiary of American Electric Power Company, Inc. (“AEP”). AEP is the parent company of Petitioner Kingsport Power Company, d/b/a AEP Appalachian Power (“KgPCo” or “Company”).

2. I am authorized to attest, represent and warrant, on behalf of the Company in this Docket, upon information and belief, that:

(A) In Docket No. 17-00032, the Tennessee Public Utility Commission (“TPUC”) approved the PETITION OF KINGSPORT POWER COMPANY, D/B/A AEP APPALACHIAN POWER FOR APPROVAL OF ITS TARGETED RELIABILITY PLAN, AND ITS TRP & MS RIDER, AN ALTERNATIVE MECHANISM.

(B) In said Docket No. 17-00032, TPUC ordered that "...Kingsport Power Company shall provide an attestation and pre-filed testimony supporting each annual filing for the mechanisms approved herein." This is the attestation of the Company as required by that Order.

(C) I testified on behalf of the Company in Docket No. 17-00032, in which the TPUC approved the Petition of Kingsport for a Targeted Reliability Plan (TRP) and a major storm (MS) alternative rate mechanism ("TRP&MS Rider"). I also testified on behalf of the Company in Docket No. 18-00125, in which the TPUC approved the Stipulation and Settlement Agreement authorizing Kingsport to recover \$2,330,677 from customers through the TRP&MS Rider effective June 1, 2019. Additionally, I testified on behalf of the Company in Docket No. 16-00001, KgPCo's most recent base rate case.

(D) I am familiar with the TRP&MS costs recorded on the Company's books and records and the level of such costs included in the Company's base rates as approved in Docket No. 16-00001.

(E) The Rider revenues, costs and expenses included herein in the Company's Petition for annual recovery under the TRP&MS Rider are complete and accurate and reflect actual amounts recorded on the Company's books and records during the 12-month period October 1, 2018 through September 30, 2019.
