Navitas TN NG, LLC ("Navitas TN" or "Navitas"), through its counsel of record, hereby submits this Motion For Further Extension of Time to File an Answer until May 22, 2020. As grounds for this Motion, Navitas states to the Commission as follows:

- 1. Navitas is scheduled to file an Answer in this docket Friday, April 24, 2020. This date is due to A previous Motion to Extend by Navitas and granted by the Hearing Officer.
- 2. A case is underway by the Kentucky PSC involving the parties to this docket which will impact this TPUC docket. It was initially thought KY PSC would render a decision by mid-April, but that did not happen. A decision may now be rendered in mid-May by the KY PSC which could lead to clarification in this docket and possible settlement.
- 3. Due to the current Coronavirus stay in place orders, compliance with the deadline is problematic.
- 4. With an extension, the interests of justice will be served in that the present docket may be settled, or at the least, some issues may be clarified.
