ORDER GRANTING MOTION TO APPEAR AND PARTICIPATE TELEPHONICALLY AT HEARING

This matter is before the Hearing Officer upon a *Notice to Appear and Participate Telephonically at Hearing ("Motion")* filed on behalf of Cumberland County, Tennessee ("Cumberland Co." or "Petitioner") on June 29, 2021. In its *Motion*, Cumberland Co. requests permission for its counsel to participate by telephone in the hearing on its *Petition Seeking Revocation of Certificate of Franchise Authority Held By Spirit Broadband, LLC ("Petition")*, scheduled before the Tennessee Public Utility Commission ("Commission") at 9:00 a.m. CDT on July 13, 2021.

Under the Tennessee Uniform Administrative Procedures Act, decisions involving telephone participation in a hearing are within the hearing officer's discretion:

(c) In the discretion of the administrative judge or hearing officer and agency members and by agreement of the parties, all or part of the hearing may be conducted by telephone, television or other electronic means, if each participant in the hearing has an opportunity to participate in, to hear, and, if technically feasible, to see the entire proceedings while taking place.²
