JOINT PETITION

Tennessee Wastewater Systems, Inc. ("TWSI" or "Company") and TPUC Staff (As a Party) ("Party Staff") (collectively, the "Parties"), pursuant to T.C.A. § 65-5-103, jointly petition the Tennessee Public Utility Commission ("Commission") for an increase to TWSI's rates and charges for the purpose of recovering the Company's costs of providing wastewater services to its customers and for authority to place such rates and charges into effect through a revised tariff.

In support of the Joint Petition, the Parties submit the following:

1. TWSI is a public utility as defined in T.C.A. § 65-4-101 and is engaged in providing wastewater services to approximately 2,760 residential customers and 804 commercial customers located in TWSI's service territories throughout Tennessee. The name and business address of the Company are:

2. The names and business address of the Party Staff are:

- 3. The currently tariffed service rates and charges of TWSI were approved by the Commission over ten years ago on July 8, 2009, in Docket No. 08-00202. Under the current rates and charges, the Company's revenues and revenue projections are not sufficient to allow the Company a fair opportunity to recover its reasonable operating costs and to provide a fair and reasonable net operating income. In order for TWSI to maintain its utility systems and provide safe and reliable services to its customers in accordance with Commission requirements, an increase to its rates and charges should be granted.
- 4. As shown by the Exhibits and Pre-filed Direct Testimonies of Party Staff witnesses Kevin McClenathan and Joe Shirley filed in support of this Joint Petition, the Company is projected to experience a net operating loss of \$105,550 for the Twelve-Month Attrition Period Ending December 31, 2020. Using the operating margin method to establish a fair margin of 10.0% of operating expenses, TWSI is projected to incur a revenue deficiency of \$449,198 during the Attrition Period absent any rate relief. The Parties propose to eliminate this revenue deficiency by increasing the monthly base rates for providing wastewater services and decreasing the monthly escrow charges reserved for capital expenditures.
- 5. With regard to Residential Customers, Commercial Customers Without Food Service, and Commercial Customers With Food Services, the Parties propose the following changes to base rates and escrow charges:

6. With regard to Commercial Cabin Customers, the Parties propose to design rates based upon the customer's cabin square footage as recorded in the county's Register of Deeds office. Currently, Commercial Cabin Customers pay a monthly base rate of \$53.20 and a monthly escrow charge of \$15.95 for up to 300 Gallons Per Day of wastewater treatment, plus an additional base rate of \$11.46 and an additional escrow charge of \$3.54 for each additional 100 Gallons Per Day. The Parties propose the following rates, charges and rate design for Commercial Cabin Customers:

- 7. In Docket No. 16-00015, the Commission ordered TWSI to record capacity development fees received from developers pursuant to contract as Contributions in Aid of Construction ("CIAC") (USOA Account No. 271) and to record per-lot, plat-signing fees received from developers pursuant to contract as Guaranteed Revenues (USOA Account No. 530). In this docket, the Parties propose to record all payments received from all developers from all sources and for all purposes as CIAC. The Parties further propose all such amounts recorded as CIAC shall be held in reserve and earmarked for capital projects unless otherwise permitted by the Commission. The Parties further propose that use of such CIAC reserves shall be governed by the same procedures for use of escrow funds as set forth in TPUC Rule 1220-04-13-.07(7) unless otherwise ordered by the Commission.
- 8. The Company notified its customers of the proposed increase to rates and charges by direct mail to the customers' billing addresses on file with the Company. A copy of the notice is attached to the Affidavit of Suzanne Christman filed in support of this Joint Petition. A copy of the notice was also posted at the Company's business offices and on the Company's website at www.tennesseewastewater.com. The notice will remain displayed until the rate hearing in this matter has been conducted or, if necessary, a re-notice issued.
- 9. In light of the Company's present negative financial position, the Parties request the Joint Petition be heard and approved at the regularly scheduled Commission Conference on March 9, 2020, with new rates and charges to become effective upon approval.
- 10. In further support of this Joint Petition, the Parties have filed herewith the following:

a. Pre-filed Direct Testimony and Exhibits of Suzanne Christman, TWSI Controller, regarding a general overview of the Company's operations and a summary of the rate relief and tariff changes requested;

b. Pre-filed Direct Testimony and Exhibits of Party Staff witnesses Kevin McClenathan and Joe Shirley regarding the ratemaking principles, methodologies and calculations used to project the revenue deficiency for the Attrition Period and to recommend the rate design to eliminate the projected revenue deficiency; and

c. Revised tariff providing the adjustments to rates and charges calculated by the Parties' cost of service study, as well as related terms of service.

WHEREFORE, the Parties jointly request the Commission to:

- 1. Schedule the Joint Petition for hearing on March 9, 2020, upon proper notice;
- 2. Find that the rates, charges and terms of service proposed by the Parties are just and reasonable and in the public interest;
- 3. Approve the Company's revised tariff implementing the proposed rates, charges and terms of service effective immediately upon approval; and
 - 4. Grant such other and further relief as circumstances may warrant.
