### **ORDER**

This matter came before Chair Robin L. Morrison, Commissioner Herbert H. Hilliard, and Commissioner David F. Jones of the Tennessee Public Utility Commission (the "Commission" or "TPUC"), the voting panel assigned to this docket, during a regularly scheduled Commission Conference held on June 15, 2020, <sup>1</sup> for consideration of the *Joint Petition* ("*Joint Petition*") filed on January 31, 2020 by Tennessee Wastewater Systems, Inc. ("TWSI" or "Company") and TPUC Staff ("Party Staff") (collectively, the "Joint Parties"). In the *Petition*, the Parties seek Commission approval of an increase of rates and charges for the purpose of recovering the Company's costs of providing wastewater services.

In convening the Commission Conference electronically, the Commission relied upon Tenn. Exec. Order No. 16 (March 20, 2020), which was extended until June 30, 2020 by Tenn. Exec. Order No. 34 (May 6, 2020), and affirmed on the record that the electronic meeting was necessary to conduct the essential business of the agency and to protect the health, safety, and welfare of Tennesseans.

#### BACKGROUND AND JOINT PETITION

TWSI is a public utility providing wastewater services to approximately 2,760 residential customers and 804 commercial customers in multiple service territories across Tennessee. The Company's most recent rate case was Docket No. 08-00202, which established rates by an order entered on July 8, 2009.<sup>2</sup>

On January 31, 2020, TWSI and Party Staff filed a *Joint Petition* requesting an increase to TWSI's rates and charges, alleging that the Company's revenues and revenue projections are not sufficient to allow TWSI to recover its reasonable operating costs and a fair and reasonable net operating income under the Company's current rates.<sup>3</sup> Along with the *Joint Petition*, the Joint Parties filed a proposed tariff and the Pre-Filed Direct Testimony of Company witness, Suzanne Christman, and Party Staff witnesses, Joe Shirley and Kevin McClenathan. TWSI filed a corrected tariff on February 5, 2020 resolving errors in the original filing.

The Consumer Advocate Unit in the Financial Division of the Office of the Tennessee Attorney General ("Consumer Advocate") filed a Petition to Intervene on February 20, 2020. The Hearing Officer entered an Order Granting the Petition to Intervene Filed by the Consumer Advocate on March 13, 2020. TWSI submitted the Pre-Filed Supplemental Testimony of Suzanne Christman on May 14, 2020. In addition, Party Staff submitted supplemental testimony of its witnesses, Joe Shirley and Kevin McClenathan. TWSI also filed a revised proposed tariff based upon agreed financial adjustments and additional accounting and reporting requirements presented in the supplemental testimonies of the Parties.

The Consumer Advocate filed correspondence to the Chair on May 15, 2020. The letter indicated that the Consumer Advocate had engaged in cooperative discussions and information exchanges with the Joint Parties. Further, based upon consideration of the entire record and the submission of the revised tariff and supplemental testimonies of Suzanne Christman, Joe Shirley, and Kevin McClenathan, "there remain no outstanding disputes between the parties with respect to this Docket...." The Consumer Advocate stated since there are no contested issues, the Consumer Advocate would not be filing testimony and the parties agreed that the matter should be resolved in favor of the positions set forth in the *Joint Petition*, as revised in the Pre-Filed Testimony of the witnesses. No other parties sought to intervene in this matter.

Attached as an exhibit to the Pre-Filed Testimony of Suzanne Christman is an affidavit of Ms. Christman indicating the Company's compliance with TPUC Rule 1220-04-01-.05. Ms. Christman certifies that customers were provided a copy of a summary of proposed changes as an insert with their January 31, 2020 bill and is available on the Company website until the conclusion of the hearing on the matter.<sup>6</sup> A copy of the customer bill insert was also provided with Ms. Christman's testimony.<sup>7</sup>

#### THE HEARING

The Hearing on the *Joint Petition* was held before the voting panel of Commissioners during the regularly scheduled Commission Conference on June 15, 2020, as noticed by the Commission on May 29, 2020. Participating in the Hearing were the following parties and their respective counsel:

The parties in this matter waived opening and closing statements, summaries of Pre-Filed Testimony, and cross-examination of the witnesses. Counsel for the parties provided an update on the status of the case and indicated the agreement of the parties. Witnesses were made available to the panel for questions.<sup>8</sup> The panel solicited comments from the public, but no member of the public sought to be heard.<sup>9</sup>

#### CRITERIA FOR ESTABLISHING JUST AND REASONABLE RATES

The Commission has jurisdiction to set the rates of public utilities operating in the State of Tennessee. <sup>10</sup> In pertinent part, Tenn. Code Ann. § 65-5-101 provides:

(a) The Tennessee public utility commission has the power after hearing upon notice, by order in writing, to fix just and reasonable individual rates, joint rates, tolls, fares, charges or schedules thereof....

In addition, Tenn. Code Ann. § 65-5-103 states, in part:

(a) When any public utility shall increase any existing individual rates, joint rates, tolls, fares, charges, or schedules thereof, or change or alter any existing classification, the commission shall have power either upon written complaint, or upon its own initiative, to hear and determine whether the increase, change or alteration is just and reasonable. The burden of proof to show that the increase, change, or alteration is just and reasonable shall be upon the public utility making the same. In determining whether such increase, change or alteration is just and reasonable, the commission shall take into account the safety, adequacy and efficiency or lack thereof of the service or services furnished by the public utility.

The Commission considers petitions for a rate increase, filed pursuant to Tenn. Code Ann. § 65-5-103, in light of the following criteria:

- 1. The investment or rate base upon which the utility should be permitted to earn a fair rate of return;
- 2. The proper level of revenues for the utility;
- 3. The proper level of expenses for the utility; and
- 4. The rate of return the utility should earn.

Applying these principles and criteria, and upon consideration of the entire record, including all exhibits and the testimony of the witnesses, the panel made the following findings and conclusions.

# FINDINGS AND CONCLUSIONS

Upon consideration of the pleadings, Pre-Filed Testimony, the entire administrative record, and the presentations of counsel of the parties at the Hearing, the panel found that the increased rates and charges proposed in the *Joint Petition*, as revised in the Pre-Filed Supplemental Testimony, are necessary for TWSI to continue providing quality wastewater service. The proposed rates and charges are just, reasonable, and in the public interest.

The panel also found that TWSI's annual revenue increase of \$404,293 represents an overall 8.2% increase in the combined base rate plus escrow rate for residential customers and an overall 8.5% increase for commercial customers. The provisions of the proposed rate increase are based upon:

- 1. An historical test period of the twelve-months ended December 31, 2018;
- 2. A forward-looking attrition period of the twelve-months ending December 31, 2020;
- 3. An Operating Margin Rate of 10%;

- 4. Total Attrition Period Operating Revenues of \$2,166,859;
- 5. Total Attrition Period Operating Expenses of \$2,270,035;
- 6. Fair Operating Margin of 10.00%;
- 7. Gross Revenue Conversion Factor of 1.34979;
- 8. Revenue Deficiency of \$404,293; and
- 9. Rate design that recovers the Revenue Deficiency in a combined increase in base rates and escrow surcharges as set forth in the Pre-Filed Supplemental Testimony of Kevin McClenathan.

The panel also found that accounting and reporting changes proposed for developer payments to the utility and the changes proposed to update TWSI's terms of service are reasonable and in the public interest and should be adopted. Therefore, the panel unanimously voted to approve the proposed increase in rates and charges. The approved rate design is attached hereto as Exhibit 1 and incorporated herein.

# IT IS THEREFORE ORDERED THAT:

- 1. The *Joint Petition* filed on January 31, 2020 by Tennessee Wastewater Systems, Inc. and TPUC Staff as a Party, as revised by the Supplemental Testimony, is approved;
- 2. The rates and charges proposed in the *Joint Petition*, as revised by the Supplemental Testimony and attached to this Order as Exhibit 1, are approved;
- 3. The accounting and reporting changes for developer payments to the utility are approved;
- 4. The updates to the terms of service of Tennessee Wastewater Systems, Inc. are approved;

5. Any person who is aggrieved by the Commission's decision in this matter may file a Petition for Reconsideration with the Commission within fifteen days from the date of this Order; and

6. Any person who is aggrieved by the Commission's decision in this matter has the right to judicial review by filing a Petition for Review in the Tennessee Court of Appeals, Middle Section, within sixty days from the date of this Order.

Chair Robin L. Morrison, Commissioner Herbert H. Hilliard, and Commissioner David F. Jones concur. None dissent.
