By this letter, Securus Technologies, Inc. ("Securus, Inc.") notifies the Commission of the change in name of Securus, Inc. to Securus Technologies, LLC ("Securus, LLC"), which became effective at the end of the day on December 31, 2019. Securus, Inc. (Company ID 128390) is authorized to provide telephone services in the State of Tennessee as a provider of customerowned coin or coinless operated telephone service and operator services in addition to reselling telecommunications services. The company previously has elected market-based service provider status.

Securus, Inc. originally was incorporated as a State of Delaware corporation. Pursuant to Title 6, Section 18-214 of the Delaware Code, it has converted to Securus, LLC. Under that provision of Delaware law, there is no dissolution or termination of the converting business entity. No new legal entity is created and there is no legal transfer of assets or Securus, Inc.'s Tennessee authorization as a result of the conversion – they remain with the same legal entity.¹

Following the conversion, Securus, LLC continues to offer and/or provide the same services as the corporate entity offered prior to the conversion. There are no changes in the rates for or the nature or extent of services for customers as a result of the conversion. Further, there is no change in management or ownership of the company as part of the conversion. Securus, LLC continues to be located at 4000 International Parkway, Carrollton, TX 75007.

Attached as Exhibit 1 is documentation showing that Securus, LLC is registered with the Tennessee Secretary of State.
