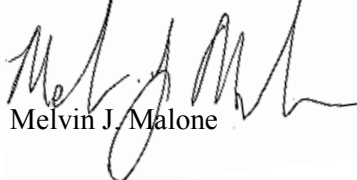
Attached for filing please find *Thunder Air, Inc. d/b/a Jasper Highlands Development, Inc.'s Revised Response Attachment to the First Discovery Requests of the Consumer Protection and Advocate Division* for Discovery Request 1-13 in the above-captioned matter. Thunder Air, Inc. is submitting a revised response to DR 1-13 because a few errors were recently discovered in the original submission. In sum, a few customers had their water meters replaced. The original attachment to DR 1-13 did not account for these customers' usage under either the old or new meters. For example, if a customer had a 70,000 usage reading in the month before the installation of a new meter, and a 5,000 usage reading the month following the installation of the new meter, the system would show a usage of negative (65,000) gallons. Although there were only a few customer readings in which this error occurred, Thunder Air, Inc. considered it best to correct those few errors and resubmit this response.

Please note that the revised attachment to the response for DR 1-13 is being submitted **UNDER SEAL** as **CONFIDENTIAL and PROPRIETARY**. Both a public version and a nonpublic, **CONFIDENTIAL** version of the revised attachment to the response for DR 1-13 are enclosed.

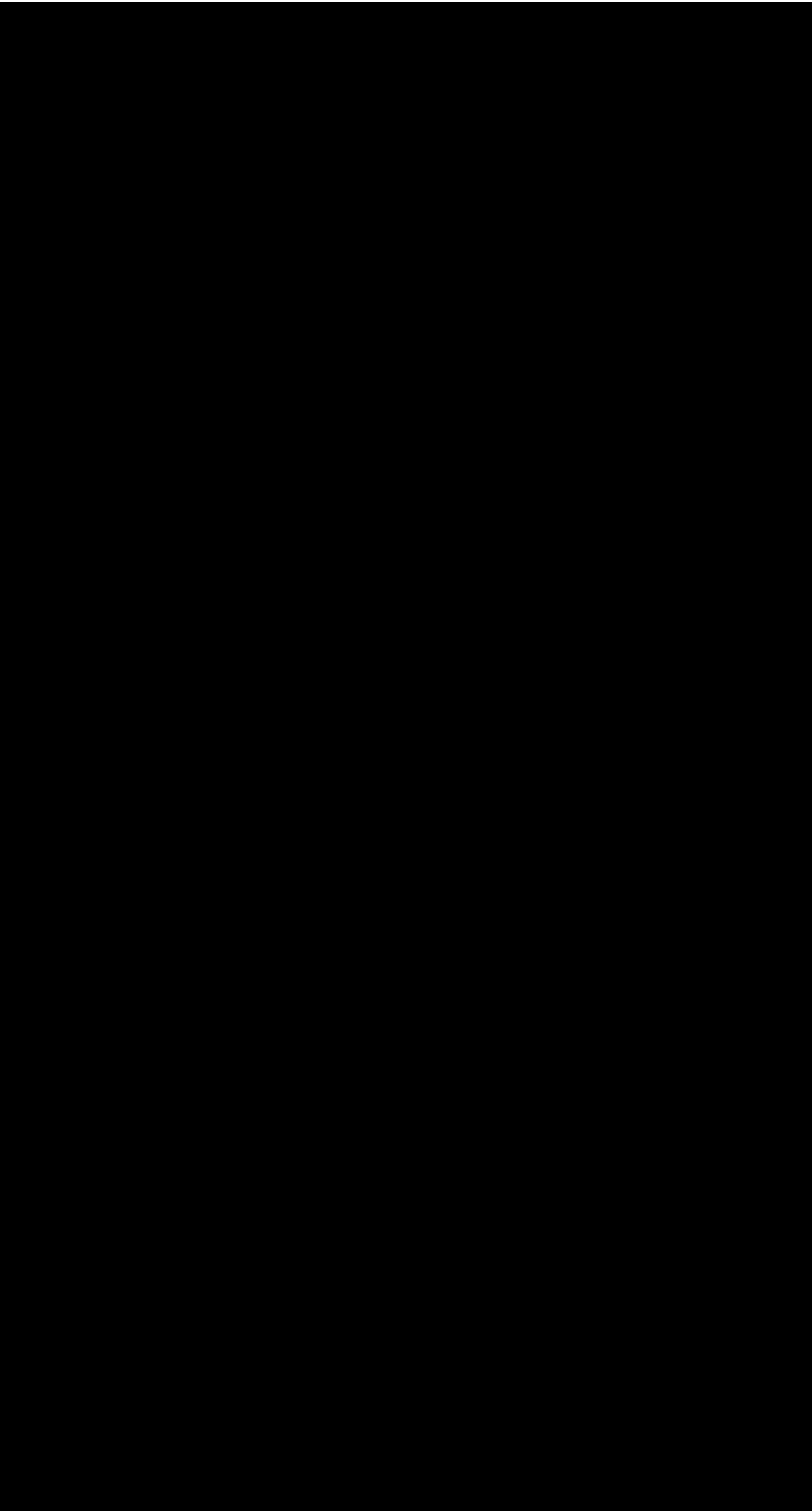
