The original and four (4) copies of this notice are submitted on behalf of West Safety Communications Inc. ("Company") to notify the Commission that the Company has changed its name to Intrado Safety Communications, Inc. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company's name as "Intrado Safety Communications, Inc." and change the Company name in all Commission records. The Company was authorized to provide resold and facilities-based telecommunications services in Tennessee under the name of Intrado Communications Inc. pursuant to authority granted in Docket No. 01-00050. In Docket No. 16-00026, the Company name was changed to West Safety Communications Inc.

A copy of the Company's Amended Certificate of Authority on file with the Tennessee Secretary of State is attached hereto as Exhibit A.

The Company has changed its name as part of a rebranding and marketing campaign by its ultimate parent company, Intrado Corporation f/k/a West Corporation.
