Good morning all.

The lobbying salary amount of \$17, 475 was just rounded to \$18,000 for settlement purposes. We thought using a round numbers of \$18K in the settlement discussions would make it easier to come to an agreement.

The revised numbers based on the settlement will result in the typical residential customer living in the City of Chattanooga having a bill decrease of \$0.88 per month or \$7.92 in 2020. The attached file shows that calculation.
