On behalf of CBTS Technology Solutions LLC (f/k/a Cincinnati Bell Any Distance Inc.) ("CBTS"), this letter advises the Tennessee Public Utility Commission ("TPUC") that CBTS elects to operate under market regulation pursuant to T.C.A. Section 65-5-109 enacted in May 2009.

In Tennessee, CBTS is authorized to provide resold and facilities-based local exchange and resold interexchange services in Tennessee pursuant to authority granted in Docket No. 03-00647, Company ID Number 128879. CBTS notified the TPUC of the name change on November 2, 2017 in Docket No. 17-00121. Until further notice, CBTS seeks to maintain, and does not withdraw, its tariffs pursuant to T.C.A. § 65-5-109(t).
