## NOTICE OF HEARING TO BE HELD ELECTRONICALLY VIA WEBEX

This matter is before the Hearing Officer on the *Application of Full Tilt Communications*, *LLC to Provide Competing Local Telecommunications Services* ("*Application*") filed by Full Tilt Communications, LLC ("Full Tilt" or "Applicant") on April 15, 2020. This matter has been scheduled for a Hearing on the merits before the Hearing Officer at **10:00 a.m. CDT on Thursday, May 28, 2020**. Due to the state of emergency declared by Governor Bill Lee relative to the Coronavirus Disease 2019 ("COVID-19") pandemic, the Hearing will be held electronically via WebEx.
