PRE-HEARING ORDER

Pursuant to Tenn. Code Ann. § 4-5-306(d) and Commission Rule 1220-1-2-.12, this matter came before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") at a Pre-Hearing Conference held via teleconference on January 6, 2021 and continued on January 8, 2021. The Pre-Hearing Conference was held to establish the orderly conduct of the Hearing on the *Piedmont Natural Gas Company Inc. Petition for an Adjustment of Rates, Charges, and Tariffs Applicable to Service in Tennessee* ("Petition") scheduled to begin via WebEx at 9:00 a.m. (CST) on Tuesday, January 19, 2021 and continue on subsequent days, as needed. Piedmont Natural Gas Company ("Piedmont" or the "Company") and the Consumer Advocate Unit in the Financial Division of the Office of the Tennessee Attorney General ("Consumer Advocate"), the parties in this matter, participated in the Pre-Hearing Conference.

PROCEDURAL MATTERS

The following order of the Hearing has been established and agreed upon:

A. NOTICE OF HEARING & PUBLIC COMMENT

On January 8, 2021, a *Notice of Hearing* was issued notifying the public that a Hearing on the *Petition* filed on July 2, 2020, will be held electronically via WebEx beginning at **9:00 a.m. CST** on Tuesday, January 19, 2021 and continuing on subsequent days, as needed. As was included in the notice, members of the public are encouraged to participate by filing written comments in the docket file by 4:00 p.m. (CST) Thursday, January 14, 2021, and/or presenting verbal comments during the Hearing.

B. OPENING STATEMENTS

After an initial public comment period is offered, each party is permitted ten (10) minutes to present an opening statement. Piedmont will present its opening statement first, followed by the Consumer Advocate.

C. EXHIBITS & DOCUMENTS

The parties should exchange any demonstrative exhibits related to a witness's prefiled testimony by Wednesday, January 12, 2021. Each party should have its own copy of all exhibits, including those appended to pre-filed testimony, available for reference during the Hearing. The parties should upload any documents to be used as exhibits during the Hearing onto the cloud share established for the Hearing if they would like assistance sharing documents electronically during the Hearing. If the parties choose to present their own exhibits electronically during the Hearing, it is not necessary for those documents to be uploaded to the cloud share.

D. TECHNOLOGICAL ISSUES

Since the Hearing is being conducted completely via WebEx video, there are special considerations the parties should observe to make sure the Hearing flows smoothly:

- Parties should log into the Hearing at <u>8:30 a.m.</u> (CST) on January 19, 2021, to make sure
 everyone is connected to the Hearing;
- Everyone should place their microphones on mute when not speaking; and
- Identify yourself prior to speaking.

E. WITNESSES

During direct examination, a time limit has been established for each witness to summarize the pre-filed testimony. In addition, each witness should be advised that he or she remains subject to recall for rebuttal purposes and should remain available throughout the length of the proceedings. F. Examination of Witnesses and Questions by the Commission

While re-direct examination of a witness is allowed, the parties are reminded that it is to be limited to matters elicited during cross-examination that require clarification. It is not appropriate to raise new issues during re-direct examination. Re-cross examination is not permitted except in the event that a new issue is raised during the immediately preceding re-direct examination. The Commission's Advisory Staff has the opportunity to ask questions following cross-examination, before re-direct examination. The parties should be aware that the Commissioners might ask questions at any time during a witness's testimony and after cross-examination.

G. Post-Hearing Briefs

The parties have decided to submit post-hearing briefs instead of give closing arguments.

Expedited transcripts will need to be ordered from the court reporter. The Hearing Officer will

establish a date for filing the post-hearing briefs, such date will not exceed two weeks after receipt of the transcript.
