Mr. Isaacs,

Per your request for information today, in order to be exempt from the bond/LOC requirement in Tennessee, your client can provide a copy of either their Ad Valorem filing with the Tennessee Comptroller of the Treasury or a copy of their Franchise and Excise filing with the Tennessee Dept. of Revenue. If they have more than \$5 million in assets in Tennessee, the company can request exemption from the bond/LOC requirement with either of these documents as proof of assets in Tennessee. Otherwise, the company will need to secure a \$20,000 bond or letter of credit to ensure the payment of any sanctions against the company for non-compliance with our rules or state

statutes. The bond and LOC forms are on our website under Forms.
