



NOTICE OF HEARING

DOCKET: 20-00103

IN RE: *Application of Mastec Network Solutions, LLC for a Certificate to Provide Access Telecommunications Services Throughout the State of Tennessee*

DATE: November 25, 2020

Pursuant to Tenn. Code Ann. § 65-4-201 *et seq.*, a hearing has been scheduled in the above-captioned matter for **Tuesday, December 8, 2020, at 3:00 p.m. (CST)**.

Due to the state of emergency declared by Governor Bill Lee relative to the Coronavirus Disease 2019 (“COVID-19”) pandemic, the Hearing will be held electronically via WebEx.¹ The ongoing state of public health emergency, which has been extended through December 27, 2020 in the entirety of the state, places limitations on public gatherings and meetings in order to prevent the spread of COVID-19.² In convening the hearing electronically, the Commission relies upon Executive Order No. 16, issued by Governor Bill Lee on March 20, 2020,³ and extended until December 27, 2020 in Executive Order No. 65⁴, and affirms that such is necessary to conduct the essential business of the agency and to protect the health, safety, and welfare of Tennesseans.
