ORDER RE-SUSPENDING TARIFF THROUGH JULY 13, 2021

This matter is before the Hearing Officer appointed by the voting panel of Commissioners of the Tennessee Public Utility Commission ("Commission" or "TPUC") and designated by General Counsel to administer certain preliminary issues that may arise during the preparation of this matter for hearing before the Commission. On November 24, 2020, pursuant to Tenn. Code Ann. § 65-5-103 *et seq.*, Kingsport Power Company d/b/a AEP Appalachian Power ("KPC") filed its *Petition of Kingsport Power Company d/b/a AEP Appalachian Power for October, 2019-September, 2020 Annual Recovery Under the Targeted Reliability Plan and Major Storm Rider ("TRP & MS"), Alternative Rate Mechanisms Approved in Docket No. 17-00032 ("Petition")*, along with the proposed tariff.

Tenn. Code Ann. § 65-5-103(a) permits the Commission, pending a hearing and determination, to suspend any rate increase, change, or alteration for an initial period not to exceed

three months from the proposed effective date of such increase, change, or alteration.¹ The Hearing Officer initially suspended the tariff through July 1, 2021, however, because the Commission's investigation, hearing, and final determination on the Company's proposed tariff cannot be completed by that date, the Hearing Officer hereby re-suspends the effectiveness of the tariff through July 13, 2021.

IT IS THEREFORE ORDERED THAT:

The effective date of the proposed Third Revised Sheet No. 21-1, T.P.U.C. Tariff Number 2 and Third Revised Sheet No. 21-2, T.P.U.C. Tariff Number 2 filed by Kingsport Power Company d/b/a AEP Appalachian Power on November 24, 2020, is hereby re-suspended through July 13, 2021, or until further order of the Tennessee Public Utility Commission, whichever occurs sooner.
