ORDER GRANTING TENNESSEE-AMERICAN'S MOTION AND ESTABLISHING AMENDED PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") for consideration of *Tennessee-American Water Company's Motion to Amend Procedural Schedule* ("*TAWC's Motion*") filed on May 18, 2021. The Hearing Officer convened a Status Conference on May 20, 2021 to discuss *TAWC's Motion. TAWC's Motion* asks the Commission to amend the procedural schedule established in this docket on May 13, 2021 because Tennessee-American Water Company's ("TAWC" or the "Company") primary witness is no longer with the Company, and TAWC needs additional time to identify a substitute witness. TAWC seeks to change the remaining dates in the Procedural Schedule, including changing the target hearing date from July to the Commission Conference in August. The Consumer Advocate Unit in the Financial Division of the Office of the Tennessee Attorney General ("Consumer Advocate") opposes *TAWC's Motion*. During the Status Conference, the Consumer Advocate made several arguments including that it would be premature to change the hearing date so far in advance without knowing whether

another witness could be identified in time to proceed with a hearing in July. The Hearing Officer finds *TAWC's Motion* is well taken and should be **GRANTED**. The Hearing Officer hereby establishes the Amended Procedural Schedule set forth in **Exhibit A** attached to this Order.
