**ORDER GRANTING CONSUMER ADVOCATE MOTION TO EXTEND DEADLINE TO SUBMIT  
PRE-FILED TESTIMONY**

---

This matter is before the Hearing Officer of the Tennessee Public Utility Commission (“Commission” or “TPUC”) for consideration of the *Consumer Advocate’s Motion to Extend Deadline to Submit Pre-Filed Testimony (“Motion”)* filed by the Consumer Advocate Unit in the Financial Division of the Office of the Tennessee Attorney General (“Consumer Advocate”) on May 25, 2021. In its *Motion*, the Consumer Advocate seeks an extension of time to file its Pre-Filed Testimony due the delay of Tennessee-American Water Company (“TAWC” or the “Company”) in responding to the Consumer Advocate’s second set of discovery requests.<sup>1</sup> The *Motion* states TAWC informed the Consumer Advocate that the Company would provide a complete response to the second set of requests by May 27, 2021.<sup>2</sup> According to the Procedural Schedule established in this docket, the Consumer Advocate’s testimony is due June 3<sup>rd</sup>. The Consumer Advocate seeks an extension to June 7, 2021 to file its Pre-Filed Testimony.<sup>3</sup>

The Hearing Officer finds the *Motion* is well taken and should be granted.

**IT IS THEREFORE ORDERED THAT:**

1. The *Consumer Advocate's Motion to Extend Deadline to Submit Pre-Filed Testimony* is **GRANTED**.

2. The Consumer Advocate Unit in the Financial Division of the Office of the Tennessee Attorney General shall file its Pre-Filed Testimony in this matter by **June 7, 2021**, unless an amended procedural order is issued in this docket that modifies the filing date.<sup>4</sup>
