Oral arguments on the *Motion to Dismiss Pursuant to TRCP 12.02(1)(2)(4)(5) and 1220-01-02-.03(2)(a)(b)(c)(d)* (“*Motion to Dismiss*”) filed on behalf of Dennis Emberling (“Emberling”) on October 30, 2023 in the above-captioned matter, are scheduled to be held before the Hearing Officer assigned to this docket on **November 30, 2023, at 10:30 a.m. (CST)** in **Hearing Room G.201** located on the Ground Floor of the Andrew Jackson State Office Building, 500 Deaderick Street, Nashville, Tennessee.

After oral arguments on the *Motion to Dismiss*, a Hearing will be convened to establish the amount of reasonable attorneys’ fees and expenses to be awarded to Tennessee Electric Cooperative Association (“TECA”) and Jackson Energy Authority (“JEA”) as ordered by the Hearing Officer in the Order issued on November 14, 2022, and affirmed by the Commission in an Order issued May 8, 2023. The Hearing Officer will conduct this Hearing in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 *et seq.*
