Re: MCImetro Access Transmission Services Corp.'s Notice of Name Change

Dear Chairman Hill:

Pursuant to Authority Rule 1220-04-01-.08, MCImetro Access Transmission Services Corp. d/b/a Verizon Access Transmission Services ("MCImetro Corp.") respectfully notifies the Commission of its name change to MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services ("MCImetro LLC") as the result of its planned conversion from a corporation to a limited liability company.

MCImetro Corp. is a Delaware corporation certificated as a competitive local exchange carrier in Tennessee that provides local exchange services throughout most of the United States.

MCImetro Corp. plans to complete the conversion on or after July 31, 2021. As a result, MCImetro Corp. has not yet registered the new name with the Office of the Tennessee Secretary of State. MCImetro Corp. therefore requests a waiver of the requirement that verification of the registration be provided with this notice. MCImetro Corp. will provide the verification of registration once it is received from the Secretary of State. MCImetro Corp. received an exemption from the surety bond requirement on November 10, 2000 so no name change is required on any surety bond.

The planned conversion to a limited liability company will not result in a change to the rates, terms, and conditions of the services that MCImetro Corp. offers to customers. MCImetro Corp. informed its customers of the name change via bill message in the May 2021 invoices. The language provided in the bill message is provided in Attachment A.
