Code Ann. § 65-4-118(b)(2), the Consumer Advocate Unit in the Financial Division of the Tennessee Attorney General's Office ("Consumer Advocate") respectfully requests the Tennessee Public Utility Commission ("TPUC") to furnish some specific records which the Consumer Advocate believes TPUC may possess that are needed for the Consumer Advocate's analysis in the above-referenced Dockets. The records requested are as follows:

1. Please provide Piedmont Natural Gas Company's "Actual Cost Adjustment Account balance" filed with the Commission for the first quarter of 2022. Specifically, the Consumer Advocate is requesting the quarterly report referenced in the Commission's *Order Adopting ACA Audit Report of Tennessee Public Utility Commission's Utilities Division.* In this *Order*, the Commission directed Piedmont Natural Gas Company, Inc. to "informally file, on a quarterly basis, its Actual Cost Adjustment Account balances with the Tennessee Public Utility Commission Staff."
