The Hearing Officer found that the proposed amended schedule submitted by Kingsport Power was reasonable, achieved the stated goals, and should be adopted. Therefore, the Hearing Officer hereby establishes the Amended Procedural Schedule set forth in Exhibit A attached to this Order.
