Ms. Brown and Mr. Goolsby,

I am the Hearing Officer assigned to the above referenced docket (filed 10/15/2021). I also issued the order overturning the code denial in the 21-00118 (filed 10/14/2021). As I review the communications between Mr. Hutton with the Commission Staff and Ms. Brown, and the subsequent request from Mr. Goolsby to Mr. Hutton, I am left with a question as to whether the second request submitted in Docket No. 21-00121 is moot.

The 21-00118 Order authorizing the issuance of 3 Thousand Blocks to Teleport appears to necessitate the opening of a new 10,000 number code. 3,000 of these numbers would satisfy the 21-00118 request leaving another 7,000 in the pool. The communications between Ms. Brown and Commission Staff appear to me to evidence an agreement that another order is not needed to accommodate the 50 number request in 21-00121.

However, if a clarifying order is needed to make clear that a fourth Thousand Block (in addition to the 3 authorized by the 21-00118 Order) is directed to be provided to TCAL in order to satisfy the F&M Bank request, then I am happy to issue an order that will hopefully not add any confusion on Somos' part. I would like to hear from both Ms. Brown and Mr. Goolsby on what TCAL believes is needed.
