On November 5, 2021, pursuant to Tenn. Code Ann. § 65-5-103(d)(6), Piedmont Natural Gas Company, Inc. ("Piedmont" or the "Company") filed its petition for approval of an Annual Review of Rates Mechanism ("ARM") in Docket No. 21-00135. As part of the Company's request in Docket No. 21-00135, Piedmont proposed to withdraw its Service Schedule No. 317 upon approval of the ARM tariff by the Tennessee Public Utility Commission ("TPUC" or the "Commission").

At the Commission Conference on October 10, 2022, the TPUC considered, and approved, the Company's ARM filing as amended.
