ORDER RE-SUSPENDING TARIFF THROUGH SEPTEMBER 30, 2022

This matter is before the Hearing Officer appointed by the voting panel of Commissioners of the Tennessee Public Utility Commission ("Commission" or "TPUC") and designated by General Counsel to administer certain preliminary issues that may arise during the preparation of this matter for hearing before the Commission. On December 1, 2021, Kingsport Power Company d/b/a AEP Appalachian Power ("Kingsport" or the "Company") filed a *Petition of Kingsport Power Company d/b/a AEP Appalachian Power for October, 2020 - September, 2021 Annual Recovery Under the Targeted Reliability Plan and Major Storm Rider ("TRP & MS"), Alternative Rate Mechanisms Approved in Docket No. 17-00032* ("Petition") requesting recovery of deferred Targeted Reliability Plan ("TRP") costs and Major Storm ("MS") expenses that were not offset by cumulative TRP&MS revenues and have not been recovered through base rates for the review

period. The Hearing Officer suspended the effectiveness of the proposed tariff through July 1, 2022.

Tenn. Code Ann. § 65-5-103(a) permits the Commission, pending a hearing and determination, to suspend any rate increase, change, or alteration for an initial period not to exceed three months from the proposed effective date of such increase, change, or alteration.¹ Because the Commission's investigation, hearing, and final determination on the Company's proposed tariff cannot be completed prior to the effective date of July 1, 2022, the Hearing Officer hereby re-suspends the effectiveness of the tariff through September 30, 2022.

IT IS THEREFORE ORDERED THAT:

The effective date of the proposed Fourth Revised Sheet No. 21-1 filed by Kingsport Power Company d/b/a AEP Appalachian Power on December 1, 2021, is hereby re-suspended through September 30, 2022, or until further order of the Tennessee Public Utility Commission, whichever occurs sooner.
