Our folks would like to hold a workship with TPSC staff and CAD, to address the implementation of the tariff and order. David, I know that henry reached out. There are two different kinds of (ofos).

There are penalties for being short, Undersupply ofo, and then there are penalties for overdelivering.

These are two separate types of orders.

On Feb 25 and 26th, the pipeline issues an order for overdelivering to much gas, (transportation customer cannot overdeliver \$15 penalty.)

 $Then when Kordsa\ below\ adjusted\ noms\ to\ underdeliver\ to\ avoid\ the\ penalty\ and\ comply\ with\ the\ order.$

Chattanooga penalized them index plus \$5.00.

That's a <u>part a penalty</u> which was meant for an ofo for u<u>ndersupply</u>. (the most common type of order.)

The company is daily balancing on these days, without a tariff in place to manage it. There is nothing in the TPSC order that addresses it .

Why penalize customers for overdelivering gas on a winter ofo day to avoid the short side penalty.

I think if we have a meeting of minds, this will be better than a room full of attorney's that don't understand this.
