CGC objects to this request as it is overly broad, unduly burdensome, oppressive, and excessively time consuming. This request is asking CGC to review all of the emails for its Gas Supply and Gas Control group to identify flow orders and to segregate out only those involving CGC, when often those emails will involve multiple Southern Company Gas LDCs and may involve otherwise information that is not relevant to this request. Subject

to and without waiving the foregoing objections, CGC states as follows: CGC is in the process of compiling responsive emails and reviewing them to redact non-CGC information. CGC hopes to have responsive information for this request as soon as possible, in the next week.

CGC SUPPLEMENTAL RESPONSE (May 4, 2022):
