PRE-FILED DIRECT TESTIMONY OF GRACE MAREK

- 1 Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.
- 2 A. My name is Grace Marek. My business address is 502 Deaderick Street, 4th Floor,
- 3 Nashville, Tennessee.
- 4 Q. BY WHOM ARE YOU EMPLOYED AND IN WHAT CAPACITY?
- 5 A. I am employed by the Tennessee Public Utility Commission. I am a Financial Regulatory
- 6 Analyst.
- 7 Q. DO YOUR RESPONSIBILITIES AT THE TENNESSEE PUBLIC UTILITY
- 8 COMMISSION INCLUDE DUTIES RELATED TO ELIGIBLE
- 9 TELECOMMUNICATIONS CARRIER ("ETC") DESIGNATIONS?
- 10 A. Yes. I review applications for designation as a wireless ETC and make recommendations
- to the Tennessee Public Utility Commission ("Commission" or "TPUC") on whether an applicant
- meets eligibility requirements and whether granting the application is in the public interest.
- 13 Q. IN THE COURSE OF YOUR DUTIES RELATED TO ELIGIBLE
- 14 TELECOMMUNICATIONS CARRIER DESIGNATION APPLICATIONS, ARE YOU
- 15 FAMILIAR WITH THE APPLICATION OF Q LINK WIRELESS, LLC?
- 16 A. Yes. On April 26, 2022, Q Link Wireless, LLC filed a Petition requesting designation as an
- 17 ETC for the sole purpose of providing Lifeline service to qualifying Tennessee consumers. The

- 18 Commission considered the application of Q Link Wireless, LLC and found that the Company did
- meet federal eligibility requirements and that it was in the public interest to grant the Company's
- 20 Petition. The Commission issued an order designating Q Link Wireless, LLC as an ETC on July
- 21 8, 2022.
- 22 Q. HAVE YOU BECOME AWARE OF ANY CHANGES TO Q LINK WIRELESS,
- 23 LLC'S ELIGIBILITY TO MAINTAIN ITS DESIGNATION AS AN ETC?
- 24 A. Yes. I have reviewed a Notice of Suspension issued by the Federal Communications
- 25 Commission ("FCC"), which prohibits Q Link Wireless from participating in the Federal Lifeline
- 26 Program. The Notice of Suspension references the guilty plea of Q Link Wireless, LLC to federal
- 27 charges relating to defrauding the Federal Lifeline Program of funds. I have also reviewed
- documents from the United States Federal District Court for the Southern District of Florida, which
- 29 include a Fact Proffer concerning Q Link Wireless, LLC, the Plea Agreement of Q Link Wireless,
- 30 LLC, and the Plea Agreement of Issa Asad, the CEO of Q Link Wireless.
- 31 Q. BASED UPON YOUR REVIEW OF THESE DOCUMENTS, DOES Q LINK
- 32 WIRELESS, LLC MEET FEDERAL ELIGIBILITY REQUIREMENTS TO BE
- 33 DESIGNATED AN ETC WITHIN THE STATE OF TENNESSEE?
- 34 A. No. Since Q Link Wireless, LLC has been suspended from participation in the Federal
- 35 Lifeline Program and has agreed that it will not participate in any program administered by the
- 36 FCC in its Plea Agreement, Q Link Wireless, LLC does not meet federal eligibility requirements
- 37 for an ETC designation in Tennessee. In addition, since the Plea Agreement and Fact Proffer
- 38 indicate that Q Link Wireless, LLC was engaged in activity that defrauded the Federal Lifeline
- 39 Program of funds between 2013 and 2019, the Petition filed by Q Link Wireless, LLC for an ETC

- 40 designation contained material misrepresentations of fact that led the Commission to grant such
- 41 designation.
- 42 Q. IS IT IN THE PUBLIC INTEREST FOR Q LINK WIRELESS, LLC TO RETAIN
- 43 ITS ETC DESIGNATION IN TENNESSEE?
- 44 A. No. On the contrary, given the ineligibility of Q Link Wireless, LLC to participate in the
- 45 Federal Lifeline Program and any other program administered by the FCC, it is not in the public
- 46 interest for Q Link Wireless, LLC to retain its ETC designation in Tennessee.
- 47 Q. IS IT IN THE PUBLIC INTEREST TO REVOKE THE ETC DESIGNATION OF Q
- 48 LINK WIRELESS, LLC?
- 49 A. Yes. Q Link Wireless, LLC has pled guilty to defrauding the Federal Lifeline Program of
- more than \$100 million dollars. As a result of this guilty plea, the Company is no longer eligible
- 51 to participate in any program administered by the FCC. Therefore, it is in the public interest that
- 52 the Commission revoke the ETC designation of Q Link Wireless, LLC.
- 53 Q. DOES THIS CONCLUDE YOUR TESTIMONY?
- 54 A. Yes.
