
Dear Chairman Hilliard:

During the time in which the above-captioned matter was pending and under consideration, it was brought to the attention of Tennessee-American Water Company ("TAWC" or "Company") that its existing tariffs continued to identify Walden's Ridge as a sale for resale customer. Walden's Ridge is no longer a TAWC sale for resale customer. At the same time, the Company was also then reminded that its existing tariffs did not list the City of Ft. Olgethorpe as a current sale for resale customer, which it has been for quite some time. The enclosed revised tariff page – TPUC No. 19, First Revised Sheet No. 4-S2, Canceling Original Sheet No. 4-S2 - removes Walden's Ridge and adds the City of Ft. Olgethorpe as a TAWC sale for resale customer.


