Telmate, LLC (the "Company") respectfully submits this letter to notify the Tennessee Public Utility Commission (the "Commission") that the Company will operate under the new assumed or doing business as ("DBA") name "ViaPath Technologies I" in the state of Tennessee. Enclosed is evidence of the assumed name as registered with the Tennessee Secretary of State. Please note, the legal name of the Company has not changed.

Please update all Commission records to reflect the Company's new DBA name. The Company holds authority to provide operator services and/or resell telecommunications and authority to provide COCOT service, which was granted in Docket Nos. 11-00181 and 11-00182 on March 4, 2013. The Company has elected to operate pursuant to market regulation in Tennessee.

The Company offers inmate calling services to correctional facilities in Tennessee, which allow incarcerated individuals to initiate telephone calls to their friends and family outside of the correctional facility. The DBA is reflected on the Company's websites and interactive voice response ("IVR") system. Only a handful of the Company's customers receive regular monthly invoices (such as bail bondsmen, attorneys, etc.), and the DBA also is reflected on those invoices.
