DSI-ITI, LLC (the "Company") respectfully submits this letter to notify the Tennessee Public Utility Commission (the "Commission") that the Company converted from a limited liability company to a corporation, and is now known as DSI-ITI, Inc. The Company also notifies the Commission that it will operate under the assumed or doing business as ("DBA") name "Via Path Tech" in the state of Tennessee. Enclosed is documentation from the Tennessee Secretary of State.

Please update all Commission records to reflect the Company's corporate conversion and new DBA name. The Company holds authority to provide operator services and resell interexchange long distance telecommunications services, which was granted in Docket No. 10-00052 on June 11, 2010, and authority to provide customer owned coin or coinless operated telephone services, which was granted in Docket No. 10-00109 on June 21, 2010. The Company has elected to operate pursuant to market regulation in Tennessee.

The Company offers inmate calling services to correctional facilities in Tennessee, which allow incarcerated individuals to initiate telephone calls to their friends and family outside of the correctional facility. The DBA is reflected on the Company's websites and interactive voice response ("IVR") system. Only a handful of the Company's customers receive regular monthly invoices (such as bail bondsmen, attorneys, etc.), and the DBA also is reflected on those invoices.
