FOURTH REPORT ON THE STATUS OF COMPLIANCE

On December 19, 2023, the Tennessee Public Utility Commission (“Commission”) issued its Order Approving Petition to Amend Certificate of Convenience and Necessity and Waive Commission Rule (“Order”).¹ The Order requires Limestone Water Utility Operating Company, LLC (“Limestone”), to file a report on the status of providing wastewater service to the Laurel Creek Subdivision, as well as the status of Limestone’s compliance with each of the filing requirements.² The Order requires that Limestone file:

- (1) the deed and/or easements for all the land and ownership rights to the wastewater system within 15 days of being issued and before the first customer is connected to the wastewater system,
- (2) as-built plans with signed certifications by Limestone indicating the wastewater system has been inspected and is approved to begin operation, and

(3) a copy of the signed plat, once the area of development is approved by the City and/or County government, within 15 days of being issued and before the first customer is connected to the wastewater system.³

Limestone reports that, as of the date of this filing, construction at the site is still ongoing, and therefore none of the above-referenced documents are available at this time. Limestone commits to file the required documents once available and within the timeframes specified in the Order.
